#### **DISCUSSION:**

Clovis Unified School District ("District") owns the real property located southeast of the intersection of North Fowler and East Herndon avenues in the City of Clovis, and bearing Fresno County Assessor's Parcel Number 550-020-47T ("Property"). The District has undertaken a public works project to design and construct new support facilities ("Project") on the Property.

The purpose of the proposed Easement is to grant FID access to the Property to install a pipeline and to conduct water through the same, including the right of unrestricted ingress and egress. The proposed Easement would prohibit the construction of any building or other permanent structure on or plant any vegetative materials within the Easement area. The proposed Deed of Easement is attached.

Pursuant to Education Code section 17557, the Board adopted on October 23, 2024, a resolution declaring its intention to convey the easement to FID and set a public hearing for this November 13, 2024, Board meeting on the question of making the conveyance. The Board will also be presented with a resolution to approve the conveyance of the easement to FID.

# PIPELINE REPLACEMENT AND EASEMENT AGREEMENT

LOCATION: S/E Herndon and Fowler avenues

APN: 550-020-47T FACILITY: Clovis No. 115

PROJECT: Clovis Unified School District – District Office Expansion

This Pipeline Replacement and Easement Agreement is made effective as of \_\_\_\_\_\_\_, 2024 ("Effective Date"), by and between (i) the Fresno Irrigation District, a California irrigation district ("District") and (ii) Clovis Unified School District, a California Unified School District ("Landowner" and/or "Grantor"), and (iii) West Valley Construction Company, Inc., A California Corportation ("Contractor").

- A. Landowner owns and/or plans to develop certain real property located in Fresno County, lying south of Herndon Avenue and east of Fowler Avenue, which includes the real property described in <a href="Exhibit A">Exhibit A</a> to this Agreement (the "Property"). A District facility commonly known as the <a href="Clovis No.115">Clovis No.115</a> pipeline traverses through the boundary of the Property (the "Pipeline" or "Improvements").
- B. District owns and operates underground irrigation pipelines located south of Herndon Avenue, east of Fowler Avenue. The District holds an exclusive easement for such pipelines under the following instrument: (i) Grant of Easement and Right of Way, dated August 26,1983, recorded November 3, 1983, as Document No. 83102166 of the Official Records of Fresno County.
- C. Landowner needs District's consent in certain matters to develop the Property. District is willing to provide such consent, subject to Landowner's providing a formal recorded and deeded easement for District's facilities (Pipeline/Improvements), and provided that Landowner agrees to replace a portion of existing pipeline with new pipeline built to the District's specifications.

D. If there are any secured lenders or others having any senior recorded interests in the Grantor's land that will be subject to the easement(s) granted hereunder, Landowner/Grantor is also willing to obtain recorded Subordination Agreements from any and all such secured lenders or others having any senior recorded interests in the Landowner's/Grantor's land that will be subject to the easement granted hereunder; and, understands that without such Subordinations, that the District's easement could be subject to divestiture should a senior interest holder or lienholder foreclose on the subject Property and thereby eliminate the easement granted hereunder.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

#### 1. Easement.

- Landowner hereby grants to District, its successors and (a) assigns, a perpetual and exclusive easement and right-of-way to construct, install, operate, use, maintain, alter, repair, improve, reconstruct, access, inspect, clean, reconfigure, redesign, traverse and/or pipe: canal(s), ditches, pipelines turnouts, gates, structures, conduits, meters, valves, measuring and/or telemetric control devices or structures, monitoring stations/devices, power lines, poles, panels and/or equipment, pumps or any other accouterments or security structures ("Improvements") the District deems helpful or necessary in connection with its rights granted under this GRANT OF EASEMENT (all hereinafter "Improvements") as determined by the District and to flow and conduct water through said pipes, canals, conduits, structures and Improvements across, over, through and under that certain real property owned by Grantor in the County of Fresno, State of California, more particularly described in Exhibit B and shown on Exhibit C to this Agreement.
- Said easement and right-of-way shall include all rights necessary, convenient or incidental to the use thereof as determined by the District including the right of unrestricted ingress to and egress from said easement, Improvements and right-of-way so described over and across said real property owned by Grantor at such times and locations and for such equipment, material, personnel and vehicles as determined by the District.
- (c) All canals, pipes, pipelines, conduits and other facilities ("Improvements") constructed, installed and/or placed by or for District upon and within said easement shall become and remain the property of District and, except as provided in Section 2(e)<sup>2</sup> and 2(h)<sup>3</sup>, shall be maintained by

District at District's expense and Grantor shall have no right, title or interest therein. When said pipes, pipelines and other structures or facilities shall be constructed installed, operated, maintained, altered, repaired, improved, reconstructed, accessed, inspected, cleaned, reconfigured, redesigned, traversed, piped, etc., the manner in which they shall be installed, constructed, maintained and/or placed by or for the District; and, the time and manner for conducting and discharging water through the same shall be in the sole, exclusive and absolute control of District.

- District hereby allows, to Grantor, the right to use the surface of the land within said easement as set forth by a separate Encroachment Agreement, for its own purposes, so long as said use by Grantor does not interfere in any way with the use of said easement by District for the purposes for which said easement is granted, the proposed use as approved in writing by District; and, provided further that Grantor shall not build or construct any building or other permanent structure on or plant any vegetative materials within said easement (including but not limited to asphalt, concrete pads, drive approaches, curbs, valley gutters, sidewalks, curb ramps, watermains, storm drains, storage sheds, carports, garages, building overhangs, pergolas, patios, pools, pool equipment, hot tubs, spas, decks, basins, kiosks, bollards, fences, gates, septic systems, leach lines, wells, entry/exit landings, or any similar improvements) without the written permission and consent of District, which permission may be withdrawn at any time by the District if Grantor's activities or improvements interfere with the District's easement. District shall have the right, without notice, and at Grantor's expense, to remove any structures, fences, or vegetative materials or other encroachments from said easement which interfere at any time with the purpose or use of said easement from time to time as determined by the District.
- (e) The foregoing easement and right-of-way is in addition to District's existing rights in the Property, and shall not constitute a surrender of such existing rights or pre-existing rights or uses by the District.
- (f) If applicable, as noted in Recital D above, Landowner will arrange for any secured lienholder having an interest in the Property subject to any easement(s) granted hereunder to submit a recordable, fully executed Subordination Agreement in form and substance acceptable to the District to be recorded contemporaneously herewith to subordinate any such lien to the easement(s) and rights of way and other interests herein conveyed to the District as a condition to the District accepting this easement, as also noted below.
- 2. <u>Pipeline Replacement</u>. Contractor shall install new pipeline within the Easement area described in <u>Exhibits B</u> as provided below to District's specifications.
  - (a) Landowner and Contractor agree at its expense to remove

existing pipe, lay, construct, and install approximately four hundred thirty-seven feet (437') of thirty inch (30") inside diameter rubber-gasket reinforced concrete pipe (ASTM C-361) (RGRCP), with such inlets, outlets, connections and other structures as may be specified by District (the "Project"). The Project shall be laid, constructed, installed, and backfilled in accordance with plans and specifications approved by District, and the top of said pipeline shall be no less than 36" below the surface of the surrounding ground and any proposed or existing roads, streets or alleys crossed thereby. All pipe shall be laid and installed in a good workmanlike manner.

- (b) All precast concrete pipe, cast-in-place concrete pipe, and any other type of pipe to be installed shall meet the minimum requirements of the then most current "American Society of Testing and Materials" specifications, "The American Concrete Institute" specifications, and the specifications and requirements of District for the type and class of pipe agreed to be installed.
- (c) The construction and installation of the Project shall not interfere with the flow, timing or distribution of water through the present facilities as required by District. No work on the Project shall begin without the written permission of District. Landowner, Contractor, and District agree and acknowledge that the construction of the Project shall not occur during the normal irrigation season of District. Contractor shall not damage, destroy, alter, disrupt, discard, remove or connect to any existing facilities owned by District (other than the portion of the Pipeline to be replaced).
- (d) Landowner and Contractor agree that the construction of the Project is subject to the District's review and approval, and that the Project must be accepted by District in writing as complying with this Agreement and District specifications. Upon such written acceptance, the Project shall become and remain the property of District. The manner, method and time (and timing) of conducting and discharging water through the Project shall be in the sole and absolute control of District.
- (e) Prior to commencement of any work on the Project, Contractor shall furnish District with a surety bond in the amount of TWO HUNDRED FIVE THOUSAND SEVEN HUNDRED THIRTY-NINE and 00/100 Dollars (\$205,739.00), guaranteeing its timely performance under this Agreement, including payment of all amounts herein agreed to be paid by Contractor. District shall have the right to request a copy of the Landowner's cost estimates and contracts for constructing the Project, including amounts payable to any contractors. If such cost is greater than Contractor's surety bond, District shall have the right to request an additional bond from Contractor, at Contractor's expense, to guarantee Contractor's timely performance. Said bond may be reduced to THIRTY THOUSAND EIGHT HUNDRED SIXTY and 85/100 Dollars (\$30,860.85) after the completion and acceptance of the Project and Contractor's payment of all costs associated

with the Project. This reduced amount shall be for guaranteeing that the Contractor will maintain and repair defects in the Contractor's work (in keeping with District-approved Standards and Specifications) on the Project discovered within a period of one (1) year from the date of District's written acceptance, as described below. The expense of such bonds shall be borne by Contractor. All bonds shall be executed by Contractor and a corporate bonding company licensed to transact such business in the State of California and acceptable to District. Evidence of authority of any attorney-in-fact acting for the corporate surety must be provided in the form of a certificate in effect as of the date of the bonds. The form of the bonds or any alternative security offered by Contractor shall be subject to the approval of the District.

- (f) Within thirty (30) days after written acceptance of the Project by District, Landowner shall pay in full any and all costs associated with the Project, including, but not limited to, costs for labor, materials, equipment, installation, trenching, backfilling, leveling and testing. In the event Landowner fails to make such payments within the time required, District may, but shall not be obligated to, pay any outstanding costs associated with the Project. Landowner shall repay District for any amounts so expended with interest thereon at the rate of ten percent (10%) per annum.
- (g) Landowner shall, at its own expense, procure a policy of title insurance issued to District with liability in the amount of TWO HUNDRED FIVE THOUSAND SEVEN HUNDRED THIRTY-NINE and 00/100 Dollars (\$205,739.00), showing title to easement granted to District in the real property described in <a href="Exhibit A">Exhibit A</a> hereto to be free and clear of encumbrances which would in any way interfere with District's use of said easement. Landowner shall furnish District with said policy after the completion and acceptance of the Project.
- Contractor will maintain and repair defects in the (h) Contractor's work (in keeping with District-approved Standards and Specifications) which are discovered within a period of one (1) year after the written acceptance thereof by District, and to pay all costs of such repairs and maintenance. District shall notify Landowner and Contractor in writing of any defects within the one year, describing, at a minimum, the particular defect(s), repairs, replacements and/or the maintenance that are necessary, the Districtapproved Standards and Specifications for such work; and, including providing the Contractor with sufficient time to make the repairs. Landowner and Contractor acknowledge that during the time that the pipeline is carrying irrigation water, storm water, surface water to municipal surface water treatment plants or other such water, that the pipeline may not be accessible or available to make the indicated repairs and/or perform the required maintenance, in which case, the time for the Contractor to effectuate such repair/maintenance work will be extended past 1 year if necessary to enable such work to be performed as quickly as possible once the pipeline is available and free of water. In the event Contractor fails to repair, maintain or replace

any part of the Project during agreed-to period when the pipeline is available, following the one (1) year period during which said work was identified, District shall have the right, but shall not be obligated to, make any such repairs or replacements that it deems reasonably necessary, and Landowner shall repay District the cost of any such repairs or replacement with interest at the rate of ten percent (10%) per annum.

- 3. <u>Indemnity</u>. Landowner and Contractor agree to defend, indemnify and hold District harmless from and against any claim, liability, loss, cost, damage, attorneys' fees or expense arising out of Landowner's and Contractor's activities in the areas described in <u>Exhibit A, B & C</u>, and the performance of Landowner's obligations under this Agreement.
- 4. <u>Costs.</u> Landowner shall pay to District the cost of the preparation of this Agreement and any related agreements regarding the Project, the costs of District's review of the Landowner's proposed development of the Property, the costs of District's review of the plans and specifications for the new pipeline. Landowner agrees such fees are non-refundable and non-transferable, and the payment of such fees may not be deferred.
- 5. <u>Subordination</u>. District's obligations under this Agreement are conditioned upon the subordination of any lien against such parcel and the Property, other than the lien for taxes not yet due, that could be foreclosed to eliminate District's recorded easement interests. District shall obtain a title report for the Property, at Landowner's expense, for the purpose of identifying such liens.
- 6. Specific Performance. Landowner and Contractor agree that District will not have an adequate remedy at law if this Agreement is not performed in accordance with its terms, and that any damages available at law for breach of this Agreement would not be an adequate remedy. Therefore, Landowner's and Contractor's obligations under this Agreement are enforceable by a decree of specific performance, and appropriate injunctive relief may be applied for and granted in connection therewith. These remedies and all other remedies provided for in this Agreement are cumulative and not exclusive and are in addition to any other remedies that District may have under this Agreement.
- 7. Further Assurances. From time to time and at any time after the execution and delivery hereof, each of the parties, at its own expense, shall execute, acknowledge and deliver any further instruments, documents and other assurances reasonably requested by the other party, and shall take any other action consistent with the terms of this Agreement that may reasonably be requested by the other party, to evidence or carry out the intent of this Agreement.

- 8. <u>Assignment; Binding Effect</u>. Neither party shall assign any interest in this Agreement without the express written consent of the other party, which shall not be unreasonably withheld. This Agreement shall "run with the land" and shall be binding upon the Property, and shall inure to the benefit of the future owners of the Property.
- 9. <u>Interpretation</u>. This Agreement is the result of negotiations between the parties and has been reviewed by their respective counsel, and is the product of their joint efforts. The parties agree that any rule of interpretation that automatically construes an ambiguous contract provision against the drafting party shall be of no effect.
- 10. <u>Professionals' Fees</u>. Should any action or proceeding be commenced between the parties hereto concerning this Agreement, or the rights and duties of any party in relation thereto, the party prevailing in such action or proceeding shall be entitled, in addition to such other relief as may be granted, to recover from the losing party a reasonable sum for its attorneys', paralegals', accountants', and other professional fees and costs incurred in connection with such action or proceeding.
- 11. Parties in Interest. Nothing in this Agreement, whether expressed or implied, is intended to confer any rights or remedies on any persons other than the parties hereto and their respective successors and assigns, nor is anything in this Agreement intended to relieve or discharge the obligation or liability of any third person to any party to this Agreement, nor shall any provision give any third person any right of subrogation or action over and against any party to this Agreement.
- 12. <u>Survival</u>. Each of the terms, provisions, representations, warranties, and covenants of the parties shall be continuous and shall survive the closing or other consummation of the transactions contemplated in this Agreement.
- 13. Notices. All notices and other communications required under this Agreement shall be in writing and shall be deemed to have been duly given (i) on the date of service, if served personally on the person to whom notice is to be given, (ii) on the date of service if sent by telecopier, provided the original is concurrently sent by first class mail, and provided that notices received by telecopier after 5:00 p.m. shall be deemed given on the next business day, (iii) on the next business day after deposit with a recognized overnight delivery service, or (iv) or on the third (3rd) day after mailing, if mailed to the party to whom notice is to be given by first class mail, registered or certified, postage-prepaid, and properly addressed as follows:

Waiver of any breach of this Agreement by any party hereto shall not constitute a continuing waiver or a waiver of any breach of the same or another provision of this Agreement. If any provision of this Agreement is held by a court of competent jurisdiction to be void or unenforceable, the remaining provisions shall remain in full force and effect and shall not be affected. 

# ACE/CTA/NEA ASL Interpreter Sunshine Proposal 10/23/2024

The Association of Clovis Educators (ACE) looks forward to bargaining a Collective Bargaining Agreement (Agreement) with the Clovis Unified School District to assist the district in attracting and retaining the very best ASL Interpreter IIs and IA III DHH staff (members) to serve the community of Clovis Unified and provide access and support to Deaf and Hard-of-Hearing Clovis Unified students. The following shall be the sunshine proposal from ACE/CTA/NEA for all matters to be bargained in the initial Agreement between the parties. These proposals are preliminary and will be subject to modification, addition, or deletion as is appropriate through the negotiations process.

# 1. Recognition

The employer, Clovis Unified School District, recognizes ACE/CTA/NEA as the exclusive representative of ASL Educational Interpreters and IA III DHH staff. This Agreement uses the term "member" to denote all represented employees under this Agreement. The parties to this Agreement shall be the ACE/CTA/NEA and Clovis Unified School District.

#### 2. Negotiation Procedure

Procedures and timelines shall be established for all future contract negotiations that are efficient and yield meaningful outcomes.

## 3. Association Rights

Association rights shall be established to ensure the association's ability to fulfill its duties and responsibilities to its members and be inclusive of members' input in decision-making in regards to roles, expectations, and responsibilities, as well as decisions that impact students' access to quality education and the community's access to our district.

# 4. Employee Rights

Employee rights ensure the fair treatment of employees and establishing clear and mutually agreeable procedures.

#### 5. Maintenance of Standards

To ensure that the agreement is implemented in a way that does not eliminate any current benefits without explicit intent from the parties and treats all unit members equitably.

#### 6. Workload

To ensure a safe and effective working and educational environment for all members and students, reasonable workload standards will be established for each member to provide meaningful access to Deaf and Hard of Hearing community members and students.

# 7. Job Duties and Working Conditions

The parties shall:

- a. Establish clarity, consistency, and fairness in regard to job duties that yield a consistent standard of practices and expectations while allowing flexibility and autonomy within the role to best support student and site needs.
- b. Provide voice and equity in obtaining necessary support and resources for our members to fulfill their roles.

### 8. Hours of Employment

To ensure sustainability and quality of service, the parties shall establish a clear schedule of member work hours and work year, including part-time opportunities, that enhances productivity and wellbeing of staff. This includes provisions for overtime and preparation time.

# 9. Assignments and Reassignment

The parties shall establish clear and equitable procedures for assignment of our members that includes the Interpreters' voice and ensure that all CUSD students have equal and appropriate access to a quality education.

# 10. Wages

The parties shall establish fair salary schedules that will help with recruitment and retention of highly qualified Interpreters, including criteria for appropriate placement on the salary schedules and compensation for additional qualifications, experience, work duties, and responsibilities to promote longevity and professional excellence.

#### 11. Health & Welfare Benefits

The parties shall establish fair benefits packages that will maintain or improve the current employee benefits; including but not limited to eligibility criteria, medical benefits, dental benefits, vision benefits, and life insurance for full and part-time employees.

#### 12. Leaves of Absence

To support the mental and physical wellbeing of the employee and their families, the parties shall develop leave policies that shall include but not be limited to: a. Sick leave b. Personal leave c. Family medical leave d. Parental leave e. Bereavement leave f. Leave for jury duty g. Court witness leave h. Military leave i. Unpaid leave j. Sabbatical leave k. Catastrophic illness/injury leave.

# 13. Evaluation

To promote a positive culture with diverse and high-quality employees, the parties shall establish a meaningful procedure for evaluation of employees that includes timelines, frequency of evaluation, clear and objective criteria, observation procedures, and a process for the mutual determination of evaluation goals, progress checks, and remediation plans if necessary.

#### 14. Safety

The parties shall establish procedures ensuring safe conditions for supporting students.

# 15. Collective Bargaining Agreement Enforcement Procedure (Grievance Procedure)

The parties shall establish a procedure to resolve differences over the enforcement of this Agreement with preference to resolving differences at the lowest possible level, and with progressive steps to allow resolution up to and including binding arbitration.

#### 16. Personnel Files

The parties shall establish consistent, transparent and fair procedures for maintaining personnel files, including procedures regarding complaints that may occur from members of the school community including teachers, parents and students.

### 17. Professional Development

The parties shall establish clear procedures for providing equitable and appropriate professional development and other career support opportunities to develop professional skills and practices.

#### 18. Savings Clause

If any portion of this contract is rendered null and void by a court of competent jurisdiction or by a change in legislation, then the remaining portions of this contract remain in full effect.

# 19. Term of Agreement (or "Effect of Agreement")

The parties shall establish a term of this Agreement and a process for opening negotiations for a successor Agreement.

# **DISCUSSION:**

At the October 6, 2021, CUSD Governing Board meeting, the Board approved Harris Construction to be the District's lease-leaseback contractor for the new 7-12 educational center and instructed the District to prepare the lease-leaseback agreement, site lease agreement and sublease agreements. Harris was also authorized to begin performing designated preconstruction services for the new educational center.

Following the October 6, 2021, Board meeting, Harris worked with the District and the project architect to perform pre-construction services including site evaluation, constructability review, design meetings, scheduling, cost estimates and construction planning.

On October 17, 2024, Harris received bids from subcontractors to construct increment five of the Terry P. Bradley Educational Center. The District participated in the bid process and prequalification of all the subcontractors to ensure that the best value is received. Following the bid opening, a two-week review by Harris Construction was conducted to evaluate best value in accordance with Education Code section 17406. A final review by Harris Construction and CUSD was conducted on October 31, 2024. At this meeting, CUSD rejected bids for Package 13 (Pool). This package will be re-bid and brought forward for approval at a later date. The sum of the subcontractors' bids is considered the "Total Sublease Amount" under the terms of the District lease-leaseback agreement with Harris Construction and will be set out in the schedule of sublease payments.

WHEREAS, the Clovis Unified School District (the "District") is in the process of developing the new Terry P. Bradley Educational Center on an approximately 160 acre site between Leonard Avenue and Highland Avenue, north and south of the Clinton Avenue alignment (the "Project"); and

WHEREAS, in connection with the Project, the District must acquire over 50 rights of way and easements as more fully depicted in Exhibit A ("Easements") in order to accommodate the construction and maintenance of the street improvements, the installation of public utilities, the relocation of existing utilities impacted by the Project, and other related infrastructure improvements and facilities related to or impacted by the Project; and

**WHEREAS**, the District's estimate of the acquisition cost is \$145,000 per acre; plus reasonable costs to repair, relocate or replace improvements impacted by the Project, as applicable; and

**WHEREAS**, it is in the best interests of the District to proceed with the acquisition of the Easements in a timely manner in order avoid any delays to the Project.

**NOW, THEREFORE**, the Governing Board of Clovis Unified School District declares, finds and resolves as follows:

**SECTION 1**. The foregoing recitals are true and correct and, by this reference, incorporated herein as if set forth in full.

SECTION 2. District Administration is authorized to negotiate and sign purchase agreements for the Easements in accordance with this Resolution, execute certificates of acceptance for the Rights of Way, open escrow, if appropriate, execute any escrow or supplementary escrow instructions relating to the purchase agreements, execute any supplementary agreements related to the possession, use, ownership of the Easements or



# RECOMMENDATION:

Adopt Resolution No. 4020 approving the conveyance of an easement to Fresno Irrigation District (FID) for installation of a pipeline and other incidental purposes regarding APN 550-020-47T. (TWO-THIRDS VOTE REQUIRED)

# **DISCUSSION:**

Clovis Unified School District ("District") owns the real property located southeast of the intersection of North Fowler and East Herndon avenues in the City of Clovis, and bearing Fresno County Assessor's Parcel Number 550-020-47T ("Property"). The District has undertaken a public works project to design and construct new support facilities ("Project") on the Property.

The purpose of the proposed Easement is to grant FID access to the Property to install a pipeline and to conduct water through the same, including the right of unrestricted ingress and egress. The proposed Easement would prohibit the construction of any building or other permanent structure on or the planting of any vegetative materials within the Easement area. The conveyance of the easement to FID is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties. Education Code section 17577 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution declaring its intention to dedicate or convey the easement and set a public hearing not less than 10 days thereafter on the question of making the conveyance.

The dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. At the October 23, 2024, Board meeting, the Board took action on the first step by adopting Resolution No. 4019, which declared its intention to convey the Easement to FID and set a public hearing to be held at this Board meeting on November 13, 2024. Resolution No. 4019 was adopted by a unanimous vote and was signed by all of the Board Members.

The Board actions for the second step are anticipated to occur at this November 13, 2024, Board meeting. At this meeting, the Board will: (1) hold the public hearing no earlier than 6:45 p.m. at 1680 David E. Cook Way, Clovis, California, on the question of making the conveyance of the Easement to FID; and (2) consider and adopt this proposed Resolution No. 4020 to approve the conveyance of the Easement to FID.

**WHEREAS,** Clovis Unified School District ("District") owns the real property located southeast of the intersection at North Fowler and East Herndon avenues in the City of Clovis, and bearing Fresno County Assessor's Parcel Number 550-020-47T ("Property").

**WHEREAS**, the District has undertaken a public works project to design and construct new administrative offices ("Project") on the Property.

WHEREAS, the District desires to grant Fresno Irrigation District (FID) a perpetual and exclusive easement and right-of-way to construct, install, operate, use, maintain, alter, repair, improve, reconstruct, access, inspect, clean, reconfigure, redesign, traverse and/or pipe: canal(s), ditches, pipeline turnouts, gates, structures, conduits, meters, valves, measuring and/or telemetric control devices or structures, monitoring stations/devices, power lines, poles, panels and/or equipment, pumps, or any other accounterments or security structures (collectively "Utility Improvements"), including a right of unrestricted ingress and egress over and across a portion of the Property, as depicted in Exhibit A ("Easement Area"). No building or other permanent structure on or the planting of any vegetative materials, will be permitted or constructed within or over the Easement Area.

WHEREAS, the conveyance of the Easement to Grantee is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection

therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties.

WHEREAS, the dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. The first step is for the Board to adopt a resolution at a meeting of the Board declaring its intention to convey the easement and set a public hearing to be held not less than 10 days thereafter. (Education Code § 17557) The second step is for the Board to: (1) hold the public hearing on the question of making the dedication or conveyance of the easement; and (2) adopt a resolution to authorize and direct the execution of a deed of dedication or conveyance of the easement and to deliver it. (Education Code § 17559) The resolution must be adopted by at least a two-thirds vote of all of the Board Members. (Education Code § 17557, 17559)

**WHEREAS**, the Board completed the first step of the process by adopting, at its Board meeting on October 23, 2024, Resolution No. 4019 declaring its intention to convey the Easement to Grantee and setting a public hearing to be held at the Board meeting on November 13, 2024.

**WHEREAS**, at the Board meeting on November 13, 2024, the Board will take action to complete the second step in the process by adopting this Resolution and approving and authorizing the actions set forth below.

WHEREAS, no protest has been filed under Education Code section 17560.

# **THEREFORE, BE IT RESOLVED** that the District's Governing Board hereby:

- 1. Declares and adopts the foregoing recitals as true and correct.
- 2. Pursuant to Education Code section 17556 et seq., approves the conveyance of the Easement on, across, and upon the Easement Area to Grantee as set forth in the agreement between Grantee and District ("Easement Agreement").
- 3. Authorizes and directs the Superintendent or designee to: (1) execute and deliver to Grantee the Easement Agreement and other documents as may be necessary to convey the Easement to Grantee, with such modifications thereto as the Superintendent or designee determines appropriate and agreed upon with Grantee; and (2) take such actions and execute such other documents as may be necessary to carry out and complete the Easement Agreement and the transaction contemplated by this Resolution.
- 4. This Resolution shall take effect immediately upon its adoption.

# **EXECUTIVE SUMMARY**

Under Education Code 17620 et seq., school districts may levy fees ("School Fees") in order to offset the impacts to school facilities from new residential and commercial development. Commencing January 1, 1987, statutory school fees were authorized to be levied in the amount of \$1.50 per square foot of new residential assessable space and \$0.25 per square foot of enclosed commercial or industrial assessable space ("Level 1 Fees"), and are subject to an increase of the statutory fees based on the Statewide cost index for Class B construction, as determined by the State Allocation Board every two years. With the passage of Senate Bill 50 (the Leroy F. Greene School Facilities Act) in 1998, the State School Facility Program was established, and provides school districts with the option of adopting alternative school fees (also known as "Level II Fees" and "Level III Fees") in excess of the Level I Fee upon meeting certain requirements, and are valid for a maximum of one (1) year.

In accordance with Government Code Sections 66001 and 66006, Clovis Unified School District ("School District") must provide certain information on an annual and five-year basis regarding the collection and expenditure of School Fees collected under the authorization of Education Code Section 17620 et seq and Government Code Section 65995 et seq. For the purposes of annual and five-year reporting requirements, the collection of School Fees do not include letters of credit and bond proceeds secured by payment of School Fees at a future date; revenues from developments under special mitigation agreements; or any other financing instrument used by the School District to fund school facilities construction and improvements.

The School District last published a report covering five-year reporting requirements (as defined under Government Code Section 66001(d)(1)) after the end of Fiscal Year ("FY") 2020/2021, and will not be required to publish relevant reporting until 180 days after the end of FY 2025/2026. Hence, the following information addresses only annual reporting requirements specified by Government Code Sections 66001 and 66006.

# ANNUAL REPORTING REQUIREMENTS

This report contains certain information regarding the type, amount, collection and expenditure of School Fees for Fiscal Year 2023/2024. Each of the capitalized letters A-H below correspond to the specific letter and portion of Government Code 66006.

# A. Type of Fee

Clovis Unified collects both Level I Fees and Level II Fees. Level I Fees are collected pursuant to Sections 17620 et seq. of the Education Code and Sections 66001 and 65995 et seq. of the Government Code. School Fees are deposited into the Capital Facilities Fund, Fund 25. Level I Fees are levied on square footage of assessable space for commercial/industrial construction/reconstruction and residential construction/reconstruction (primarily residential additions), Additionally, pursuant to Sections 65995.5, 65995.6, and 65995.7 of the Government Code, the School District collected Level II Fees.

# B. Amount of Fee

For collection purposes, all unmitigated residential construction/reconstruction in the School District was subject to School Fees in the amounts set forth in the table below.

Approving these MOUs for periods effective July 1, 2021, July 1, 2022, and July 1, 2023, will ensure that our employees' retirement benefits accurately reflect their longevity pay and it is creditable towards their retirement incentive.

Professional Growth Pay is another form of special compensation available to employees hired before July 1, 2006. This program was created to support classified employees in advancing their skills and knowledge within their career paths. The MOU for Professional Growth Pay will secure this compensation as part of the retirement incentive calculation for eligible employees.

The District previously began construction of a Special Education Administration building and an Online School on 16.61 acres located southeast of the intersection of North Fowler and East Herndon avenues in the City of Clovis. The District now proposes to commence the second phase of the project to construct and operate new facilities on 5.08 adjoining acres. The second phase would include four buildings and associated site infrastructure including parking, required for a business office building and three shop buildings.

As required by the California Environmental Quality Act, the District has prepared an Initial Study to determine whether the project has the potential to result in significant effects on the environment. The Initial Study determined that although the project could have a significant effect on the environment, there would not be a significant effect because the District has incorporated into the project mitigation measures that would avoid any significant effects of the project or reduce the effects to an insignificant level. Therefore, a Mitigated Negative Declaration is proposed for adoption by the Board.

The District provided notice of its intent to adopt a Mitigated Negative Declaration to public agencies and nearby property owners and residents for a 30-day public review period from October 9, 2024, through November 8, 2024. Additionally, notice was published in The Business Journal on October 16, 2024. Copies of the public notice, Initial Study and Mitigated Negative Declaration are available for review at the District Office and the District website: www.cusd.com/EnvironmentalReports.aspx.

# ADOPTING A MITIGATED NEGATIVE DECLARATION FOR DISTRICT CAMPUS PHASE II PROJECT

WHEREAS, the Clovis Unified School District ("District") previously began construction of Phase I of the District Campus Project consisting of a Special Education Administration building and an Online School on 16.61 acres located southeast of the intersection of N. Fowler and E. Herndon avenues in the City of Clovis ("Phase I"); and

**WHEREAS,** the District is now proposing to undertake Phase II of the District Campus Project on 5.08 acres adjoining the Phase I site within Assessor's Parcel Number 550-020-47T ("Project"); and

WHEREAS, the Project includes the construction and operation of four buildings and associated site infrastructure, including parking, required for an administration office building ("Building A") and shop buildings ("Buildings B, C, and D"); and

WHEREAS, the District has prepared an Initial Study - Mitigated Negative Declaration ("IS-MND") for the Project in compliance with the California Environmental Quality Act ("CEQA") and the State CEQA Guidelines; and

**WHEREAS,** notice that the District proposed to adopt the IS-MND for the Project was provided to the public within a reasonable period of time prior to the date on which the IS-MND was scheduled for adoption; and

WHEREAS, the IS-MND identified potentially significant effects which the Project could have but the District agreed to mitigation measures before the proposed IS-MND was released for public review, which will avoid the effects or mitigate the effects to a point where no significant impacts will occur; and

WHEREAS, all comments received from agencies and the public in response to the proposed IS-MND have been provided to the Governing Board for review; and

**WHEREAS**, there is no substantial evidence before the Board that the Project may have a significant effect on the environment; and

WHEREAS, the District has prepared a Mitigation Monitoring Reporting Program (MMRP) for the Project.

**THEREFORE, BE IT RESOLVED**, that the Governing Board of the Clovis Unified School District makes the following findings:

SECTION 1. The Board adopts the foregoing recitals as true and correct.

SECTION 2. The Board hereby finds that the IS-MND reflects the independent judgment of the District as CEQA Lead Agency for the Project.

SECTION 3. The Board hereby finds that the IS-MND has been completed in compliance with CEQA; and that the Board has independently reviewed and considered the IS-MND, together with all comments received during the public review process, prior to adopting the IS-MND and approving the Project.

SECTION 4. The Board, based on the IS-MND and the comments received, hereby finds there is no substantial evidence the Project may have a significant effect on the environment.

SECTION 5. The Board hereby confirms that the mitigation measures listed in the IS-MND have been incorporated into the Project, adopts the MMRP, and adopts the IS-MND for the Project.

SECTION 6. The Board, based on information in the IS-MND prepared for the Project, hereby finds that the Project site is not, and has not been, a hazardous waste disposal site or solid waste disposal site; the Project site is not a hazardous waste release site identified by the State Department of Health Services; the Project site does not contain pipelines situated underground or above-ground which carry hazardous substances, acutely hazardous materials, or hazardous wastes; and the Project site is not within 500 feet of the edge of the closest land of a freeway or other busy traffic corridor as defined in Education Code section 17213(d)(9) or Public Resources Code section 21151.8(b)(9).

SECTION 7. The Board, based on information in the IS-MND prepared for the Project, hereby finds that the District consulted with the San Joaquin Valley Air Pollution Control District and Fresno County Environmental Health Division, per Public Resource Code section 21151.8 and Education Code section 17213 to identify any facilities within one-fourth mile of the site which might reasonably be anticipated to emit hazardous emissions or handle hazardous or acutely hazardous materials, substances, or waste. Based on the information provided in the IS-MND, there are no such facilities within one-fourth mile of the site that would constitute an actual or potential endangerment of public health to persons who would attend or be employed at the facilities.

SECTION 8. The Board hereby approves the Project.

SECTION 9. The Board hereby authorizes the Superintendent or her designee to file a Notice of Determination for the Project.

#### RECOMMENDATION:

Adopt Resolution No. 4023 authorizing the Superintendent or designee to submit an application to the San Joaquin Valley Air Pollution Control District (SJVAPCD) to participate in the New Alternative Fuel Vehicle Grant Program.

#### **DISCUSSION:**

Clovis Unified has the opportunity to participate in the SJVAPCD New Alternative Fuel Grant Program to purchase alternative fuel vehicles. The grant will be awarded on a first-come, first-served basis. If awarded, the grant will provide funding up to \$100,000 per agency, per calendar year.

The District is requesting approval to submit an application to replace seven (7) electric utility carts. The utility carts will be purchased for the Custodial and Grounds departments at a cost of \$15,063.37 each, for a total of \$105,443.59.

This item will appear on the December 13, 2024, consent agenda.

#### FISCAL IMPACT/FUNDING SOURCE:

If awarded, the grant will fund \$100,000 of the purchase. The remaining \$5,443.59 will be funded with General Fund budget monies allocated to equipment replacement.

WHEREAS, funds have been appropriated to the San Joaquin Valley Air Pollution Control District (SJVAPCD) for New Alternative Fuel Vehicle Purchase.
