DISCUSSION:

Clovis Unified School District ("District") owns the real property located at 2501 N. Highland Ave., Fresno, CA 93727, in the County of Fresno, and bearing Fresno County Assessor's Parcel Numbers 310-320-03ST, 310-320-05ST, 310-320-06ST, and 310-050-38T ("Property"). The District has undertaken a public works project to design and construct a new educational center including a high school and an intermediate school ("Project") on the Property. A portion of the Project is anticipated to be completed by August 2025.

The purpose of the proposed easement is to grant FMFCD access to the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same, including a right of ingress thereto and egress therefrom. The proposed easement would prohibit the construction of any structures within the easement area, including buildings, roof overhangs and swimming pools. The proposed Deed of Easement is attached.

Pursuant to Education Code section 17557, the Board adopted on August 7, 2024, a resolution declaring its intention to convey the easement to FMFCD and set a public hearing for this August 28, 2024, meeting. The Board will also be presented with a resolution to approve the conveyance of the easement to FMFCD.

GRANT OF EASEMENT AND RIGHT-OF-WAY

THIS GRANT OF EASEMENT AND RIGHT-OF-WAY, is made and entered into this ____ day of _____, 20__ by and between Clovis Unified School District, a California unified school district, as Grantor, and Fresno Metropolitan Flood Control District, a California public corporation in the County of Fresno, State of California, as Grantee.

WITNESSETH

That Grantor, for good and valuable consideration, does hereby grant to Grantee a perpetual and exclusive easement in, through, over, and under that real property in the County of Fresno, State of California described in Exhibit "A" (the "Easement"), attached hereto and incorporated herein by this reference, to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same, together with all rights necessary, convenient or incidental thereto, including a right of ingress thereto and egress therefrom over Grantor's property as described in Exhibit "B" hereto (the "Property"), provided that such access shall not unreasonably interfere with Grantor's enjoyment of the Property.

No structures (including, but not limited to, buildings, roof overhangs and swimming pools) shall be constructed within the Easement, and no trees may be planted therein, but shrubs and grasses may be planted and sidewalks and parking areas may be installed on the Easement. In the event the Grantee damages improvements thereto in the use of reasonable care and enjoyment of the Easement, it shall not be obligated to restore the same or be liable for any damages whatsoever related thereto.

This Easement shall "run with the land" and be binding upon and inure to the benefit of Grantor's heirs, executors, administrators, assigns and successors.





Approve the Provisional Internship Permit (PIP) for the recommended teaching candidates, as submitted.

DISCUSSION:

The PIP is available when the employing agency knows that there will be a teacher vacancy yet is unable to recruit a suitable candidate. The expectations of the employer and the employee are higher since this individual will be the teacher of record and should be on a credential track. The focus of the document is meeting subject matter competency. Once a candidate completes subject matter competency, the candidate can be employed on a document such as a District Internship Credential. Candidate requirements include the following: (1) Bachelor's degree or higher; (2) passage of the California Basic Educational Skills Test (CBEST); and (3) specific course work or experience, explained in detail on the PIP information leaflet.

As required by the California Commission on Teacher Credentialing (CCTC), employing agencies offering employment to a candidate on a PIP are required to: (1) conduct a diligent search for a suitable credentialed teacher or qualified internship teacher; (2) provide the PIP holder with orientation, guidance, and assistance as specified in Title 5 Section 80026.5 of the California Code of Regulations; (3) assist the PIP holder in developing a personalized plan (kept on file at the local level) through an agency-defined assessment leading to completion of subject matter competence; and (4) counsel the PIP holder to enroll in subject matter training. Clovis Unified School District administration hereby declares that a diligent search was conducted for suitable credentialed teachers or qualified internship teachers. Upon Board approval, District administration asserts that steps 2-4, as outlined above, will be completed.

School districts submitting PIP requests must include verification that a notice of intent to employ the applicant in the identified position was made public. The public notice must include the following information: (1) the names of the applicants; (2) the assignments in which the applicants will be employed including subjects, grade levels, and school sites; and (3) a statement that the applicants will be employed on the basis of a PIP. Clovis Unified intends to submit a PIP request for the following teacher candidates, contingent upon administration and Board approval:

CommonLit will be utilized as a supplemental material for intervention and to enhance our core curriculum. Students benefit from diverse and thought-provoking texts that promote critical thinking and analytical skills. These texts will also be utilized in Curriculum Design Teams to develop District common assessments. The program includes built-in scaffolds and accessibility tools, ensuring all students can access the material, regardless of their reading level. Teachers have access to high-quality, research-backed content and structured lessons designed to reach all learners. The digital platform also features built-in professional development resources, with partnerships providing virtual training sessions for teachers and school leaders throughout the year.

DISCUSSION:

AMP aims to support youth in bringing about positive youth development in students that have experienced or are experiencing adverse circumstances and provide mentorship and community resources to meet the needs of those students.

The overall goal and objective of AMP is to help foster a supportive learning environment and assist in facilitating the success of students' academic goals and the needs of the whole person. Through meaningful relationships and support, the mentorship program is structured to enhance student participation, increase engagement in learning, and cultivate student skills and confidence for future success.

AMP will provide mentoring services five days per week to all students enrolled in Clovis Community Day, Clovis Online and Gateway High schools. Mentors will strive to build relationships in a manner that assists in identifying each student's unique path for development. Additionally, mentors will introduce incentives that will aim to motivate and inspire students to actively engage in and complete tasks. The incentives are carefully designed to enhance participation, sustain interest, and cultivate excitement among students.

FISCAL IMPACT/FUNDING SOURCE:

Total cost of agreement for 2024-25 school year is \$168,030, which will be funded through LCAP and Title I resources.

RECOMMENDATION:

Adopt Resolution No. 4003 approving the conveyance of an easement to Fresno Metropolitan Flood Control District (FMFCD) for installation of a storm drain and other incidental purposes regarding APNs 310-320-03ST, 310-320-05ST, 310-320-06ST and 310-050-38T (TWO-THIRDS VOTE REQUIRED).

DISCUSSION:

Clovis Unified School District ("District") owns the real property located at 2501 N. Highland Ave., Fresno, CA 93727, in the County of Fresno, and bearing Fresno County Assessor's Parcel Numbers 310-320-03ST, 310-320-05ST, 310-320-06ST, and 310-050-38T ("Property"). The District has undertaken a public works project to design and construct a new educational center including a high school and an intermediate school ("Project") on the Property. The first phase of the Project is anticipated to be completed by August 2025.

The purpose of the proposed easement is to grant FMFCD access to the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same, including a right of ingress thereto and egress therefrom. The proposed easement would prohibit the construction of any structures within the easement area, including buildings, roof overhangs and swimming pools.

The conveyance of the easement to FMFCD is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties. Education Code section 17577 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution declaring its intention to dedicate or convey the easement and set a public hearing not less than 10 days thereafter on the question of making the conveyance.

The dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. At the August 7, 2024, Board meeting, the Board adopted Resolution No. 4002 declaring its intention to convey the easement to FMFCD and set a public hearing for this Board meeting on August 28, 2024. Resolution No. 4002 was unanimously adopted.

The Board actions for the second step are anticipated to occur at this Board meeting on August

28, 2024. At this meeting, the Board will: (1) hold the public hearing on the question of making the conveyance of the easement to FMFCD; and (2) consider and adopt the proposed Resolution No. 4003, attached, to approve the conveyance of the easement to FMFCD.

WHEREAS, Clovis Unified School District ("District") owns the Property listed above and described in Exhibit A attached hereto.

WHEREAS, The District has undertaken a public works project to design and construct a new educational center including a high school and an intermediate school ("Project") on the Property. A portion of the Project is anticipated to be completed by August 2025.

WHEREAS, the District desires to grant Fresno Metropolitan Flood Control District (FMFCD) a perpetual and exclusive easement in, through, over, and under the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same (collectively "Utility Improvements"), including a right of ingress and egress over and across a portion of the Property, as depicted in Exhibit A ("Easement Area"). No structures, including buildings, roof overhangs and swimming pools, will be permitted or constructed within or over any drainage easement. No trees may be planted therein. Said access easement must be kept clear for potential future use.

WHEREAS, the conveyance of the Easement to Grantee is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties.

WHEREAS, the dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. The first step is for the Board to adopt a resolution at a meeting of the Board declaring its intention to convey the easement and set a public hearing to be held not less than 10 days thereafter (Education Code § 17557). The second step is for the Board to: (1) hold the public hearing on the question of making the dedication or conveyance of the easement; and (2) adopt a resolution to authorize and direct the execution of a deed of dedication or conveyance of the easement and to deliver it (Education Code § 17559). The resolution must be adopted by at least a two-thirds vote of all of the Board members (Education Code § 17557, 17559).

WHEREAS, the Board completed the first step of the process by adopting, at its Board meeting on August 7, 2024, Resolution No. 4002 declaring its intention to convey the Easement to Grantee and setting a public hearing to be held at the Board meeting on August 28, 2024.

WHEREAS, at the Board meeting on August 28, 2024, the Board will take action to complete the second step in the process by adopting this Resolution and approving and authorizing the actions set forth below.

WHEREAS, no protest has been filed under Education Code section 17560.

THEREFORE, BE IT RESOLVED that the District's Governing Board hereby:

- 1. Declares and adopts the foregoing recitals as true and correct.
- 2. Pursuant to Education Code section 17556 et seq., approves the conveyance of the Easement on, across, and upon the Easement Area to Grantee as set forth in the agreement between Grantee and District ("Easement Agreement").
- 3. Authorizes and directs the Superintendent or designee to: (1) execute and deliver to Grantee the Easement Agreement and other documents as may be necessary to convey the Easement to Grantee, with such modifications thereto as the Superintendent or designee determines appropriate and agreed upon with Grantee; and (2) take such actions and execute such other documents as may be necessary to carry out and complete the Easement Agreement and the transaction contemplated by this Resolution.
- 4. This Resolution shall take effect immediately upon its adoption.





Title: Resolution No. 4004 - Exemption to the Separation-from-Service Requirement for One Certificated Retiree

RECOMMENDATION:

Adopt Resolution No. 4004, approving an exemption to the separation-from-service requirement for the 2024-25 school year (Education Code § 24214.5 or 26812).

DISCUSSION:

California Education Code sections 24214.5 or 26812 authorizes the Governing Board to permit a 180-calendar-day separation-from-service requirement for all retired CalSTRS members and participants receiving an annuity. There is, however, a narrow exemption from the 180-calendar-day separation-from-service requirement if the retired member is appointed to a critically needed position.

At this time, the District is in critical need of English as a Second Language (ESL) teachers to provide services to students and collaborate with educators, parents and other professionals to create a safe, healthy and supportive learning environment. Currently, a shortage of ESL teachers exists nationwide, statewide and districtwide.

Recommended for this position is retired veteran teacher Melanie Franz who served the District for 30 years. Ms. Franz is a credentialed teacher who would be able to provide critical services for our ESL students. Due to growth and the existing shortage, there is a critical need to utilize a qualified retiree working outside the scope of her previous position. It is recommended that the Governing Board meet this critical need by requesting an exemption to the 180-day wait period for a CalSTRS retiree.

RESOLUTION FOR THE EXEMPTION TO THE SEPARATION FROM SERVICE REQUIREMENT FOR THE 2024-25 SCHOOL YEAR (Education Code §24214.5 or 26812)

WHEREAS, pursuant to Education Code sections 24214.5 or 26812, there is a 180-calendar-day separation-from-service requirement for all retired CalSTRS members and participants; and

WHEREAS, all retired CalSTRS members and participants are subject to a restriction if they perform retired member activities as defined by section 22164.5 of the Education Code or retired participant activities as defined by section 26135.7 of the Education Code, during the first 180 calendar days after their most recent retirement; and

WHEREAS, if the retired CalSTRS member or participant performed retired member or participant activities during this period, CalSTRS will reduce his or her retirement benefit or annuity one dollar for each dollar earned for performing retired member or participant activities during the 180-day period; and

WHEREAS, there is an exemption from the 180-calendar-day separation-from-service-requirement for a member or participant who retires from service and is at or above normal retirement age; and

WHEREAS, in order to qualify for this narrow exemption, the employer must appoint the retired member or participant to a crucially needed position that has been approved by the governing body of the employer in a public meeting as reflected in a resolution; and

WHEREAS, this approval by the governing body of the employer in a public meeting as reflected in a resolution must be finalized and communicated to CalSTRS before the member or participant commences to perform retired member or participant activities; and

WHEREAS, the Superintendent must complete the Request for Separation-from-Service-Requirement Exemption Form, which must be submitted to CalSTRS and received by CalSTRS before the member or participant commences to perform retired member or participant activities.

THEREFORE, BE IT RESOLVED that this Board does provide public notice that the District is in critical need of teachers in the specialized field of English as a Second Language (ESL) for Clovis Adult Education. Recommended for this position is veteran teacher Melanie Franz, who served the District for 30 years. Ms. Franz is a credentialed teacher that will provide instruction in ESL as part of our multi-level class which serves all levels of students as they enter our leveled ESL classes. In addition, Ms. Franz will provide services in our Adult Basic Education classes to further support our students at Clovis Adult Education. This critical need is paramount for the continued growth and development of our adult learners who rely on high-quality ESL education to improve their career prospects and integration into the community. Therefore, it is recommended that the Governing Board meets this critical need by requesting an exemption to the 180-day wait period for a CalSTRS retiree.

- **BE IT ALSO RESOLVED** that the Board wishes to meet this critical need by hiring Melanie Franz, a member or participant who retired for service less than 180 days ago.
- **BE IT ALSO RESOLVED** that this appointment is needed to fill this critical need before the 180-calendar-day separation-from-service requirement is fulfilled.
- **BE IT ALSO RESOLVED** that this member or participant did not receive a retirement incentive or any financial inducement to retire from any public employer.
- **BE IT ALSO RESOLVED** that the retired member's or participant's termination of employment is not the basis for the need to acquire his or her services.
- **BE IT ALSO RESOLVED** that the earnings for retired member activities during the 180 calendar days will still be subject to the annual postretirement earnings limit for the Defined Benefit Program.
- **BE IT ALSO RESOLVED** that this member or participant will not commence to perform retired member or participant activities before this approval is authorized by the governing body of the employer in a public meeting as reflected in a resolution and received by CalSTRS.
- **BE IT ALSO RESOLVED** that this member or participant will not commence to perform retired member or participant activities before the Superintendent completes the Request for Separation-from-Service Requirement Exemption Form and this is transmitted to and received by CalSTRS.

RECOMMENDATION:

Adopt Resolutions No. 4005 and 4006 authorizing Clovis Unified School District to hire two CalPERS retirees prior to the 180-day post-retirement waiting period.

DISCUSSION:

A retiree can return to work for a school district employer without reinstating into active service and without an impact on their pension benefit if they return to work for one of the following reasons (Government Code Section 7522.56):

- An emergency to prevent stoppage of public business.
- The retiree has skills needed to perform work of limited duration.

A public agency retiree cannot return to work for at least 180 days after retirement unless the following conditions are met (Government Code 7522.56):

- The employer certifies that the appointment is necessary to fill a critically needed position before 180 days have passed.
- The appointment has been approved by the governing body of the employer in a public meeting.

The District deems it essential to appoint retirees John Meyers and Luis Galindo to fulfill the vital role of Student Resource Officers, which are currently vacant and urgently required. These positions carry the responsibility of providing critical safety needs for our schools and community. The District remains actively engaged in recruiting for these positions. Officers Meyers and Galindo possess the necessary experience and expertise to carry out these responsibilities until the vacancies are filled. It is important to note that the employment of these retirees will be restricted to 960 hours per officer for the 2024-25 fiscal year.

RESOLUTION FOR THE EXEMPTION TO THE SEPARATION-FROM-SERVICE REQUIREMENT FOR THE 2024-25 SCHOOL YEAR (Government Code § 7522.56 and 21221)

WHEREAS, in compliance with Government Code section 7522.56 of the Public Employees' Retirement Law, the Clovis Unified School District's Governing Board must provide CalPERS this certification resolution when hiring a retiree before 180 days have passed since his or her retirement date; and

WHEREAS, John Meyers (ID No. 1621) retired from Clovis Unified School District in the position of School Resource Officer, effective June 7, 2024; and

WHEREAS, Government Code section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is December 5, 2024, without this certification resolution; and

WHEREAS, Government Code section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

WHEREAS, the Clovis Unified School District and John Meyers certify that John Meyers has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the Clovis Unified School District hereby appoints John Meyers as an interim appointment retired annuitant to the vacant position of School Resource Officer for the Clovis Unified School District under Government Code section 21221(h), effective August 29, 2024; and

WHEREAS, an appointment under Government Code section 21221(h) requires an active, publicly posted recruitment for a permanent replacement; and

WHEREAS, the current status of this recruitment is ongoing, in process and posted with insufficient applicants; and

WHEREAS, this Government Code section 21221(h) appointment shall only be made once and therefore will end on June 6, 2025; and

WHEREAS, the entire employment agreement, contract or appointment document between John Meyers and the Clovis Unified School District has been reviewed by this body and is attached herein; and

WHEREAS, no matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

In order to comply with the requirements of GASB 75, the District secured the services of Foster & Foster Actuaries and Consultants, to perform an actuarial study of the District's retiree health liabilities or OPEB. This actuarial report is required at least once every two years.

The results of the actuarial study will be provided to all members of the Governing Board with their agenda materials for the September 11, 2024, meeting.

Title: Resolution No. 4009 – Annual Recalculated 2023-24 Gann Limit Appropriation and Estimated 2024-25 Gann Limit Appropriation

RECOMMENDATION:

Adopt Resolution No. 4009 to recalculate the 2023-24 Gann Limit Appropriation and estimate the 2024-25 Gann Limit Appropriation.

DISCUSSION:

The Gann Limit, named for Paul Gann, the author of Proposition 4 which amended the State Constitution to establish this limit, is intended to constrain the growth in state and local government spending by linking year-to-year changes in expenditures to changes in inflation (represented by per capita personal income) and population (represented by average daily attendance (ADA) for schools). Established in 1979 following the enactment of Proposition 13 and subsequently amended by Proposition 111, the Gann Limit has become a largely pro forma calculation that no longer constrains governmental expenditures. This is because the limit has grown significantly faster than appropriations subject to the limit.

Education Code Section 42132 requires that on or before September 15 of each year, the governing board adopt a resolution to identify the estimated appropriations limit for the current fiscal year and the actual appropriations limit for the preceding fiscal year.

Clovis Unified is required to perform Gann Limit calculations by the State Constitution, but it is also important for the District to complete these calculations to identify how much state aid counts toward its Gann Limit and, ultimately, the state's own Gann Limit.

The worksheet reflecting the recalculated 2023-24 Gann Limit Appropriation for the District and the estimated Gann Limit Appropriation for 2024-25 will be provided to the Governing Board prior to the September 11, 2024, Governing Board meeting.
