Conduct a Public Hearing no earlier than 6:45 p.m. at 2770 East International Avenue, Fresno, 93730, regarding the conveyance of a public utility easement to Pacific Gas and Electric Company, APN 574-130-01T.

DISCUSSION:

Clovis Unified School District (District) owns the real property located between McKinley and Clinton avenues, and Fowler and Armstrong avenues in the City of Fresno, County of Fresno, State of California and designated as a portion of APN 574-130-01T (Property).

The District has undertaken a public works project to design and construct a new elementary school (Project) on the Property.

To connect gas, electricity, and other services to the Property, work is needed by Pacific Gas and Electric Company (PGE), a public utility, to excavate, construct, install and maintain certain facilities and equipment. PGE desires to acquire an easement over a portion of the Property for the purpose of excavating, constructing, reconstructing, replacing, removing, maintaining, inspecting, and using such facilities and equipment.

Pursuant to Education Code section 17557, the Board adopted on July 17, 2024, a resolution declaring its intention to convey the easement to PGE and set a public hearing for no earlier than 6:45 p.m. on August 7, 2024, on the question of making the conveyance. The meeting and public hearing will be held at Clovis North High School Lecture Hall, 2770 E. International Avenue, Fresno, CA 93730. During this meeting the Board will also be presented with a resolution to approve the conveyance of the easement to PGE.

DISCUSSION:

The Clovis Community Sports and Recreation Department provides and operates noneducational, athletic and recreation programs and activities for the access and enjoyment of Clovis and surrounding communities. Such noneducational, recreational programs and activities are not part of the District's curricular, extracurricular, or co-curricular educational programs, and are entirely separate and distinct from the District's educational program. The Department's recreational offerings are available to all age-appropriate participants in Clovis, Fresno and surrounding communities, whether or not such participants are enrolled in the District's educational program, and students enrolled in the District's educational program are never required to participate in the Department's noneducational, recreational programs or activities.

This outcome would address feedback received over time from parents seeking easier ways to stay engaged with their child's school while also making it easier for staff to communicate. The platform also features translation capabilities to increase engagement with second language families as well as secure document delivery, a content management system, social media integration, attendance, reporting and online payment features.

For the above reasons, the District piloted (at no cost) this platform during the 2024 Summer Session. Based on the positive review by users along with additional due diligence research by the Communications and Technology departments, the District has determined to move forward with rolling out ParentSquare with the start of the 2024-25 school year. The fall semester would be used to navigate a shift from existing, disparate platforms in use across the District to ParentSquare.

The chart below summarizes one-time, on-going and potential future expenses to implement the platform at all of our schools and programs. If approved, expenses already in the budget that currently pay for the District's auto notification/email/text/website/app systems, along with purchases of a variety of communication platforms in use by individual schools and/or programs, would be replaced as contracts expire. This would allow costs associated with this agreement to be offset by savings in other platforms no longer used in the District.

DISCUSSION:

California Education Code section 42603 authorizes school districts to make inter-fund loans between funds. It is in the best interest of the District to allow such loans in order to facilitate the investing of money and to avoid having to borrow money from outside financial institutions when one of the funds may have a cash shortage. This inter-fund loan process is utilized only as authorized by the California Education Code, which requires that the loan be repaid in the same year, or subsequent year, if borrowing takes place within 120 days of the fiscal year-end. The Education Code also does not allow more than 75% of the money held in any fund during the current fiscal year to be transferred. District Administration recommends the Board approve a resolution authorizing these inter-fund loans during the fiscal year of 2024-25, as needed.

DISCUSSION:

Clovis Unified School District (District) owns the real property located between McKinley and Clinton avenues, and Fowler and Armstrong avenues in the City of Fresno, County of Fresno, State of California and designated as a portion of APN 574-130-01T (Property).

The District has undertaken a public works project to design and construct a new elementary school (Project) on the Property.

To connect gas, electricity, and other services to the Property, work is needed by Pacific Gas and Electric Company (PGE), a public utility, to excavate, construct, install and maintain certain facilities and equipment. PGE desires to acquire an easement over a portion of the Property for the purpose of excavating, constructing, reconstructing, replacing, removing, maintaining, inspecting, and using such facilities and equipment. The Easement Deed that is part of the proposed resolution is attached hereto.

The conveyance of the easement to PGE is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties. Education Code section 17559 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution authorizing and directing the execution of a deed of dedication or conveyance of the property and deliver it.

At its regular Board meeting on July 17, 2024, the Board voted to adopt Resolution No. 3999, declaring its intention to convey a public utility easement to PGE and setting a Public Hearing to be held this August 7, 2024, Board meeting. Notice of the public hearing was posted and published in accordance with Education Code section 17558. No protest has been filed under Education Code section 17560.

PGE desires to acquire an easement over a portion of the Property for the purpose of excavating, constructing, reconstructing, replacing, removing, maintaining, inspecting, and using such facilities and equipment (Utility Improvement Purposes). The Deed of Easement and attached map (Easement Area) is set forth in the attached Exhibit A; and

WHEREAS, the Easement Area is not now and will not at the time of the proposed delivery of possession and title to PGE be needed exclusively for classroom or other school purposes by the District; and

WHEREAS, the Utility Improvement Purposes to be carried out by PGE will benefit the District; and

WHEREAS, it is in the best interest of the District to transfer ownership of said Easement Area to PGE in that PGE will carry out the Utility Improvement Purposes.

utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties; and

WHEREAS, Education Code section 17557 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution declaring its intention to dedicate or convey the easement and set a public hearing not less than 10 days thereafter on the question of making the conveyance. At its regular Board meeting on July 17, 2024, the Board adopted Resolution No. 3999, declaring its intention to convey a public utility easement to PGE and setting a public hearing to be held on August 7, 2024. Notice of the public hearing was posted and published in accordance with Education Code section 17558. On August 7, 2024, the Board held a public hearing regarding the conveyance of the public utility easement to PGE; and

WHEREAS, Education Code section 17559 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution authorizing and directing the execution of a deed of dedication or conveyance of the property and deliver it. By this resolution, the Board intends to authorize and direct the Superintendent or designee to execute the deed of conveyance of the Property and deliver it to PGE; and

WHEREAS, no protest has been filed under Education Code section 17560.

THEREFORE, BE IT RESOLVED that the District's Governing Board hereby:

- 1. Declares and adopts the foregoing recitals as true and correct.



Adopt Resolution No. 4002 declaring the intention to convey an easement to Fresno Metropolitan Flood Control District (FMFCD) and set a Public Hearing for installation of a storm drain and other incidental purposes, APNs 310-320-03ST, 310-320-05ST, 310-320-06ST, 310-050-38T (TWO-THIRDS VOTE REQUIRED).

DISCUSSION:

Clovis Unified School District ("District") owns the real property located at 2501 N. Highland Avenue, Fresno, California, 93727, in the County of Fresno, and bearing Fresno County Assessor's Parcel Numbers 310-320-03ST, 310-320-05ST, 310-320-06ST, and 310-050-38T ("Property"). The District has undertaken a public works project to design and construct a new educational center including a high school and an intermediate school ("Project") on the Property. The first phase of the Project is anticipated to be completed by August 2025.

The purpose of the proposed Easement is to grant FMFCD access to the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same, including a right of ingress thereto and egress therefrom. The proposed Easement would prohibit the construction of any structures within the Easement area, including buildings, roof overhangs and swimming pools.

The conveyance of the easement to FMFCD is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties. Education Code section 17577 requires the governing board, by not less than a two-thirds vote of all of its board members, to adopt a resolution declaring its intention to dedicate or convey the easement and set a public hearing not less than 10 days thereafter on the question of making the conveyance.

The dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. At the August 7, 2024 board meeting, the Board will take action on the first step by adopting the proposed Resolution No. 4002 that is attached. By adopting the proposed Resolution, the Board would declare its intention to convey the Easement to FMFCD and set a public hearing to be held at the Board meeting on August 28, 2024. Proposed Resolution No. 4002 is attached and must be adopted by at least a two-thirds vote of all of the

Board members and be signed by the Board members or a majority thereof.

The Board actions for the second step are anticipated to occur at the Board meeting on August 28, 2024. At that meeting, the Board will: (1) hold the public hearing on the question of making the conveyance of the Easement to FMFCD; and (2) consider and adopt a resolution to approve the conveyance of the Easement to FMFCD.

WHEREAS, Clovis Unified School District ("District") owns the real property located at 2501 N. Highland Avenue, Fresno, California, 93727, in the County of Fresno, and bearing Fresno County Assessor's Parcel Numbers 310-320-03ST, 310-320-05ST, 310-320-06ST, and 310-050-38T ("Property").

WHEREAS, The District has undertaken a public works project to design and construct a new educational center which includes a high school and an intermediate school ("Project") on the Property. The Project is anticipated to be completed by August 2025.

WHEREAS, the District desires to grant Fresno Metropolitan Flood Control District (FMFCD) a perpetual and exclusive easement in, through, over, and under the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same (collectively "Utility Improvements"), including a right of ingress and egress over and across a portion of the Property, as depicted in Exhibit A ("Easement Area"). No structures, including buildings, roof overhangs and swimming pools, will be permitted or constructed within or over any drainage easement. No trees may be planted therein. Said access easement must be kept clear for potential future use.

WHEREAS, the conveyance of the Easement to FMFCD is authorized by the California Education Code. WHEREAS, by this Resolution and pursuant to Education Code section 17557, the Board intends to declare its intention to convey the Easement on, across, and upon the Easement Area to FMFCD, and to fix a date and time for the public hearing upon the question of making the dedication or conveyance of the Easement to FMFCD.

THEREFORE, BE IT RESOLVED that the District's Governing Board hereby:

- 1. Declares and adopts the foregoing recitals as true and correct.
- 2. Declares its intention to convey the Easement on, across, and upon the Easement Area to FMFCD for the Utility Improvements, such an Easement as stated in Exhibit A and to be set forth in a deed of easement or other similar documents with such terms and conditions as agreed upon by the District and FMFCD.
- 3. Fixes the date and time of the public hearing upon the question of making the conveyance of the Easement as follows: No earlier than 6:45 p.m. on August 28, 2024, the Board shall hold a public hearing upon the question of making the conveyance of the Easement to FMFCD. The meeting shall be held at the Board's regular place of meeting, Boardroom, 1680 David E. Cook Way, Clovis, California.
- 4. The Superintendent or designee is authorized and directed to give notice of the adoption of this Resolution and of the time and place of holding the meeting at which the public hearing shall be conducted. The notice shall be given by posting a copy of this Resolution and by publishing written notice as required by law.
- 5. This Resolution shall take effect immediately upon its adoption.





Title: Provisional Internship Permit

RECOMMENDATION:

Approve the Provisional Internship Permit for the recommended teaching candidate, as submitted.

DISCUSSION:

The Provisional Internship Permit (PIP) is available when the employing agency knows that there will be a teacher vacancy yet is unable to recruit a suitable candidate. The expectations of the employer and the employee are higher since this individual will be the teacher of record and should be on a credential track. The focus of the document is meeting subject matter competency. Once a candidate completes subject matter competency, the candidate can be employed on a document such as a District Internship Credential. Candidate requirements include the following: (1) Bachelor's degree or higher; (2) passage of the California Basic Educational Skills Test (CBEST); and (3) specific course work or experience, explained in detail on the Provisional Internship Permit information leaflet.

As required by the California Commission on Teacher Credentialing (CCTC), employing agencies offering employment to a candidate on a Provisional Internship Permit are required to: (1) conduct a diligent search for a suitable credentialed teacher or qualified internship teacher; (2) provide the PIP holder with orientation, guidance, and assistance as specified in Title 5 Section 80026.5 of the California Code of Regulations; (3) assist the PIP holder in developing a personalized plan (kept on file at the local level) through an agency-defined assessment leading to completion of subject matter competence; and (4) counsel the PIP holder to enroll in subject matter training. Clovis Unified School District administration hereby declares that a diligent search was conducted for suitable credentialed teachers or qualified internship teachers. Upon Board approval, District administration asserts that steps 2-4, as outlined above, will be completed.

School districts submitting Provisional Internship Permit requests must include verification that a notice of intent to employ the applicants in the identified positions was made public. The public notice must include the following information: (1) the name of the applicant(s); (2) the assignment in which the applicant(s) will be employed including subject(s), grade level(s), and school site; and (3) a statement that the applicant(s) will be employed on the basis of a Provisional Internship Permit. Clovis Unified intends to submit a Provisional Internship Permit request for the following teacher candidate, contingent upon administration and Board approval:

The program includes built-in scaffolds and accessibility tools, ensuring all students can access the material, regardless of their reading level. Teachers have access to high-quality, research-backed content and structured lessons designed to reach all learners. The digital platform also features built-in professional development resources, with partnerships providing virtual training sessions for teachers and school leaders throughout the year.

The fiscal impact for a three-year contract with CommonLit is \$120,750 over three years, to be included in the Curriculum, Instruction and Accountability budget.

WHEREAS, the District desires to grant Fresno Metropolitan Flood Control District (FMFCD) a perpetual and exclusive easement in, through, over, and under the Property to install, construct, operate, maintain, repair, remove and replace an underground storm drainage pipeline and to conduct water through the same (collectively "Utility Improvements"), including a right of ingress and egress over and across a portion of the Property, as depicted in Exhibit A ("Easement Area"). No structures, including buildings, roof overhangs and swimming pools, will be permitted or constructed within or over any drainage easement. No trees may be planted therein. Said access easement must be kept clear for potential future use.

WHEREAS, the conveyance of the Easement to Grantee is authorized by the California Education Code. Pursuant to Education Code section 17556, a school district governing board may dedicate or convey to any public corporation or private corporation engaged in the public utility business an easement to lay, construct, reconstruct, maintain, and operate water, sewer, gas, or storm drain pipes or ditches, electric or telephone lines, and access roads used in connection therewith, over and upon any land belonging to the school district, upon such terms and conditions as agreed to by the parties.

WHEREAS, the dedication and conveyance of an easement pursuant to Education Code section 17556 et seq. is a two-step process. The first step is for the Board to adopt a resolution at a meeting of the Board declaring its intention to convey the easement and set a public hearing to be held not less than 10 days thereafter. (Education Code § 17557) The second step is for the Board to: (1) hold the public hearing on the question of making the dedication or conveyance of the easement; and (2) adopt a resolution to authorize and direct the execution of a deed of dedication or conveyance of the easement and to deliver it. (Education Code § 17559) The resolution must be adopted by at least a two-thirds vote of all of the Board Members. (Education Code § 17557, 17559)

WHEREAS, the Board completed the first step of the process by adopting, at its Board meeting on August 7, 2024, Resolution No. 4002 declaring its intention to convey the Easement to Grantee and setting a public hearing to be held at the Board meeting on August 28, 2024.

WHEREAS, at the Board meeting on August 28, 2024, the Board will take action to complete the second step in the process by adopting this Resolution and approving and authorizing the actions set forth below.

WHEREAS, no protest has been filed under Education Code section 17560.

THEREFORE, BE IT RESOLVED that the District's Governing Board hereby:

- 1. Declares and adopts the foregoing recitals as true and correct.
- 2. Pursuant to Education Code section 17556 et seq., approves the conveyance of the Easement on, across, and upon the Easement Area to Grantee as set forth in the agreement between Grantee and District ("Easement Agreement").
- 3. Authorizes and directs the Superintendent or designee to: (1) execute and deliver to Grantee the Easement Agreement and other documents as may be necessary to convey the Easement to Grantee, with such modifications thereto as the Superintendent or designee determines appropriate and agreed upon with Grantee; and (2) take such actions and execute such other documents as may be necessary to carry out and complete the Easement Agreement and the transaction contemplated by this Resolution.
- 4. This Resolution shall take effect immediately upon its adoption.





Title: Resolution No. 4004 - Exemption to the Separation-from-Service Requirement for One Certificated Retiree

RECOMMENDATION:

Adopt Resolution No. 4004, approving an exemption to the separation-from-service requirement for the 2024-25 school year (Education Code § 24214.5 or 26812).

DISCUSSION:

California Education Code sections 24214.5 or 26812 authorizes the Governing Board to permit a 180-calendar-day separation-from-service requirement for all retired CalSTRS members and participants receiving an annuity. There is, however, a narrow exemption from the 180-calendar-day separation-from-service requirement if the retired member is appointed to a critically needed position.

At this time, the District is in critical need of English as a Second Language (ESL) teachers to provide services to students and collaborate with educators, parents and other professionals to create a safe, healthy and supportive learning environment. Currently, a shortage of ESL teachers exists nationwide, statewide and districtwide.

Recommended for this position is retired veteran teacher Melanie Franz who served the District for 30 years. Ms. Franz is a credentialed teacher who would be able to provide critical services for our ESL students. Due to growth and the existing shortage, there is a critical need to utilize a qualified retiree working outside the scope of her previous position. It is recommended that the Governing Board meet this critical need by requesting an exemption to the 180-day wait period for a CalSTRS retiree.

RESOLUTION FOR THE EXEMPTION TO THE SEPARATION FROM SERVICE REQUIREMENT FOR THE 2024-25 SCHOOL YEAR (Education Code §24214.5 or 26812)

WHEREAS, pursuant to Education Code sections 24214.5 or 26812, there is a 180-calendar-day separation-from-service requirement for all retired CalSTRS members and participants; and

WHEREAS, all retired CalSTRS members and participants are subject to a restriction if they perform retired member activities as defined by section 22164.5 of the Education Code or retired participant activities as defined by section 26135.7 of the Education Code, during the first 180 calendar days after their most recent retirement; and

WHEREAS, if the retired CalSTRS member or participant performed retired member or participant activities during this period, CalSTRS will reduce his or her retirement benefit or annuity one dollar for each dollar earned for performing retired member or participant activities during the 180-day period; and

WHEREAS, there is an exemption from the 180-calendar-day separation-from-service-requirement for a member or participant who retires from service and is at or above normal retirement age; and

WHEREAS, in order to qualify for this narrow exemption, the employer must appoint the retired member or participant to a crucially needed position that has been approved by the governing body of the employer in a public meeting as reflected in a resolution; and

WHEREAS, this approval by the governing body of the employer in a public meeting as reflected in a resolution must be finalized and communicated to CalSTRS before the member or participant commences to perform retired member or participant activities; and

WHEREAS, the Superintendent must complete the Request for Separation-from-Service-Requirement Exemption Form, which must be submitted to CalSTRS and received by CalSTRS before the member or participant commences to perform retired member or participant activities.

THEREFORE, BE IT RESOLVED that this Board does provide public notice that the District is in critical need of teachers in the specialized field of English as a Second Language (ESL) for Clovis Adult Education. Recommended for this position is veteran teacher Melanie Franz, who served the District for 30 years. Ms. Franz is a credentialed teacher that will provide instruction in ESL as part of our multi-level class which serves all levels of students as they enter our leveled ESL classes. In addition, Ms. Franz will provide services in our Adult Basic Education classes to further support our students at Clovis Adult Education. This critical need is paramount for the continued growth and development of our adult learners who rely on high-quality ESL education to improve their career prospects and integration into the community. Therefore, it is recommended that the Governing Board meets this critical need by requesting an exemption to the 180-day wait period for a CalSTRS retiree.

- **BE IT ALSO RESOLVED** that the Board wishes to meet this critical need by hiring Melanie Franz, a member or participant who retired for service less than 180 days ago.
- **BE IT ALSO RESOLVED** that this appointment is needed to fill this critical need before the 180-calendar-day separation-from-service requirement is fulfilled.
- **BE IT ALSO RESOLVED** that this member or participant did not receive a retirement incentive or any financial inducement to retire from any public employer.
- **BE IT ALSO RESOLVED** that the retired member's or participant's termination of employment is not the basis for the need to acquire his or her services.
- **BE IT ALSO RESOLVED** that the earnings for retired member activities during the 180 calendar days will still be subject to the annual postretirement earnings limit for the Defined Benefit Program.
- **BE IT ALSO RESOLVED** that this member or participant will not commence to perform retired member or participant activities before this approval is authorized by the governing body of the employer in a public meeting as reflected in a resolution and received by CalSTRS.
- **BE IT ALSO RESOLVED** that this member or participant will not commence to perform retired member or participant activities before the Superintendent completes the Request for Separation-from-Service Requirement Exemption Form and this is transmitted to and received by CalSTRS.

RECOMMENDATION:

Adopt Resolutions No. 4005 and 4006 authorizing Clovis Unified School District to hire two CalPERS retirees prior to the 180-day post-retirement waiting period.

DISCUSSION:

A retiree can return to work for a school district employer without reinstating into active service and without an impact on their pension benefit if they return to work for one of the following reasons (Government Code Section 7522.56):

- An emergency to prevent stoppage of public business.
- The retiree has skills needed to perform work of limited duration.

A public agency retiree cannot return to work for at least 180 days after retirement unless the following conditions are met (Government Code 7522.56):

- The employer certifies that the appointment is necessary to fill a critically needed position before 180 days have passed.
- The appointment has been approved by the governing body of the employer in a public meeting.

The District deems it essential to appoint retirees John Meyers and Luis Galindo to fulfill the vital role of Student Resource Officers, which are currently vacant and urgently required. These positions carry the responsibility of providing critical safety needs for our schools and community. The District remains actively engaged in recruiting for these positions. Officers Meyers and Galindo possess the necessary experience and expertise to carry out these responsibilities until the vacancies are filled. It is important to note that the employment of these retirees will be restricted to 960 hours per officer for the 2024-25 fiscal year.
