## Placement in Ninth Grade Mathematics Courses

### Annual Report 2024-25

Beginning in the 2016-17 school year, Clovis Unified implemented protocols for mathematics placement of entering ninth grade students, pursuant to Board Policy No. 6152.1. This policy requires that the Governing Board and the Superintendent or designee annually review aggregate data to ensure that students who qualify to progress in mathematics courses are not held back in a disproportionate manner based on ethnicity, gender, or socioeconomic background.

For the 2024-25 school year, the District report states that one student out of 3,546 ninth graders is misplaced in a mathematics course their ninth grade year. One parent requested that their student enroll in Math 1, which is the equivalency of repeating the eighth grade Advanced math course, even though they qualified to enroll in the next course.

The low number of mathematics misplacement resulted in no findings of disproportionate placement. Clovis Unified high schools will continue to implement the adopted protocol to ensure that ninth grade students progress appropriately in the mathematics course sequence for college and/or career readiness.

**DISCUSSION:**

Governmental Accounting Standards Board Statement 75 (GASB 75) requires government agencies to account for Other Post-Employment Benefits (OPEB) in their financial statements using the full accrual method. Currently, the District pays for the OPEB costs annually on a pay-as-you-go basis. Beginning with the 2008-09 fiscal year financial statements, the District has been required to show the liability of these benefits on its financial statements.

In order to comply with the requirements of GASB 75, the District secured the services of Foster & Foster Actuaries and Consultants, to perform an actuarial study of the District's retiree health liabilities or OPEB. This actuarial report is required at least once every two years.

The results of the actuarial study are as follows:

The Actuarial Accrued Liability of the District's OPEB is \$499.7 million. This figure represents the present value of retiree health benefits that has accrued for each employee and retiree since they were hired. With respect to the actuarial report, this amount is unfunded.

The Normal Cost, estimated at \$586.8 million, is the annual cost of service accrual for the upcoming fiscal year for active employees. This can be thought of as the cost for OPEBs being earned by employees in exchange for services now.

The net change to the OPEB obligation that will appear in the District's 2023-24 financial statements is \$107.4 million.

The pertinent information contained in the Actuarial Study will be incorporated into the District's 2023-24 Annual Financial Report.

**FISCAL IMPACT:**

No impact on the 2024-25 budget as the cost is already included in the Adopted Budget on a "pay-as-you-go" basis. Estimated pay-as-you-go costs for the next several years are as follows:

Dear Susan:

This report sets forth the results of our GASB 75 actuarial valuation of the District's retiree health insurance program as of July 1, 2024.

GASB 74 and GASB 75 require public employers such as the District to perform periodic actuarial valuations to measure and disclose their retiree healthcare liabilities for the financial statements of both the employer and the trust, if any, set aside to pre-fund these liabilities.

The District selected DFA, LLC (DFA)—acquired by Foster & Foster Consulting Actuaries, Inc. (Foster & Foster) as of January 1, 2024—to perform an actuarial valuation of the retiree health insurance program as of July 1, 2024. This report may be compared with the valuation performed by DFA, LLC as of July 1, 2022, to see how the liabilities have changed since the last valuation.

**Basis for Actuarial Valuation**

To perform the valuation, we relied on the following information provided by the District:

- Census data for active employees and retirees
- Claims, premium, expense, and enrollment data
- Copies of relevant sections of healthcare documents, and
- (If applicable) trust statements prepared by the trustee

We also made certain assumptions regarding rates of employee turnover, retirement, and mortality, as well as economic assumptions regarding healthcare inflation and interest rates. Our assumptions are based on a standard set of assumptions used for similar valuations, modified as appropriate for the District. A complete description of the actuarial assumptions used in the valuation is set forth in the Actuarial Assumptions section.



### **Certification**

The actuarial certification, including a caveat regarding limitations of scope, if any, is contained in the Actuarial Certification section.

We have enjoyed working with the District on this project and are available to answer any questions you may have concerning any information contained herein.

### **Disclosure of Risk**

It is important to call attention to external risk factors associated with actuarial projections. Certain trends and events have the potential to affect future measurements that would deviate from current long-term expectations. The following is a list of specific factors that impact OPEB liabilities:

- Census – retirement, turnover, and mortality experience different than expected.
- Medical coverage – premiums, participation, and level of coverage different than expected.
- Municipal bond rates – changes in applicable rates (rates are currently declining and may result in increased liabilities). Under GASB 75, the municipal rate may affect the discount rate. The quantitative effect of changes in the discount rate can be seen in the sensitivity results.
- Investment performance – (for funded plans) investment performance different than the long-term expected return. Investment performance may also affect the discount rate.

The current environment's impact on these factors will continue to unfold. We are available to discuss both the short-term and long-term impact upon request.

## Financial Results

In this section, we present financial results based on a long-term expected return on general assets of 4.00%. This rate is based on our best estimate of expected long-term plan experience for unfunded plans such as the District's. The results are intended to help (1) in comparing financial results from the previous valuation and (2) in long-term budget and strategic planning (without regard to short-term volatility in municipal bond indices). Results specific to GASB 75 reporting are presented in the next section.

We have determined that the present value of all benefits expected to be paid by the District for its current and future retirees is \$756,767,737 as of July 1, 2024. If the District were to place this amount in a fund earning interest at the rate of 4.00% per year, and all other actuarial assumptions were exactly met, the fund would have exactly enough to pay all expected benefits.



When we apportion the \$756,767,737 into past service and future service components under the Entry Age, Level Percent of Pay Cost Method, the Total OPEB Liability is \$496,952,553 as of July 1, 2024. This represents the present value of all benefits accrued through the valuation date if each employee's liability is expensed from hire date until retirement date as a level percentage of pay. The \$496,952,553 is comprised of liabilities of \$321,265,892 for active employees and \$175,686,661 for retirees.

The District has not adopted an irrevocable trust for the pre-funding of retiree healthcare benefits.

This valuation includes benefits for 1,465 retirees and 3,909 active employees who may become eligible to retire and receive benefits in the future. It excludes employees hired after July 1, 2024.



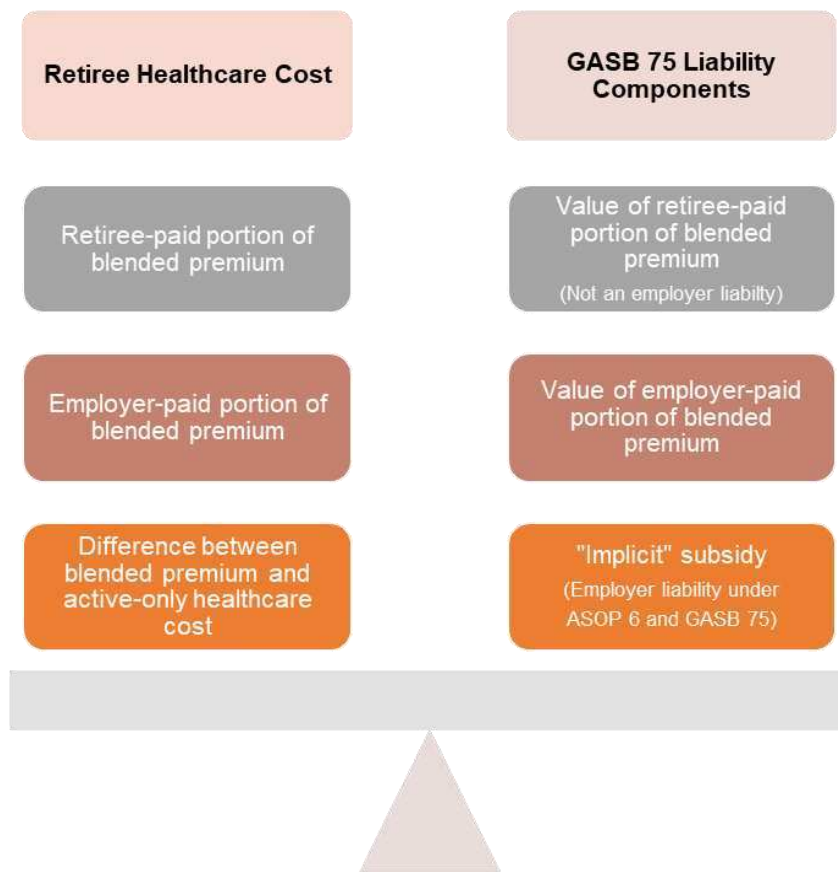
## Financial Results (continued)

### **ASOP 6 – Age-Specific Costs and Implicit Subsidy**

To determine age-specific claims, we used an age-specific claim cost matrix fitted to projected retiree claims from the 2020 actuarial review of District’s self-funded program. The valuation reflects no implicit subsidy.

Actuarial Standard of Practice No. 6 (ASOP 6) provides guidance in measuring OPEB obligations and determining periodic costs or actuarially determined contributions. The standard specifies that (in almost all instances) the actuary should use age-specific costs in the development of the initial per capita costs and in the projection of future benefit plan costs.

When claims experience of both active employees and retirees are pooled in determining healthcare premiums, a retiree may pay an amount based on a blended pool of members that, on average, is younger and healthier. In a pooled environment, retiree claims are covered by premiums charged to the retiree plus an added cost included in active premiums. Blended premium charged represents an “explicit” cost, while the added cost represents an “implicit” cost.



## Financial Results (continued)

### Differences from Prior Valuation

The most recent prior valuation was completed as of July 1, 2022 by DFA, LLC. The Total OPEB Liability as of that date was \$371,921,307, compared to \$496,952,553 as of July 1, 2024 (determined using a discount rate of 4.00%).

Several factors have caused the Total OPEB Liability to change since 2022:

- An increase as employees accrue more service and get closer to receiving benefits.
- A decrease from a release of benefits.
- Changes in the plan census from new employees and differences between actual and expected retirement, terminations, and deaths.
- Changes in healthcare costs from differences between actual and expected healthcare trend; and
- Changes in actuarial assumptions and methodology for the current valuation.

To summarize, the most important changes were as follows:

1. An increase of \$31,771,634 from the passage of time (service and interest costs less benefits paid).
2. An increase of \$11,431,994 resulting from population experience (terminations, retirements, and mortality) different than expected.
3. An increase of \$32,210,775 from changes in healthcare claims different than expected.
4. An increase of \$44,647,808 from changes in the healthcare trend rate.
5. An increase of \$16,685,462 from change in assumed termination of employment rates.
6. A decrease of \$11,716,427 from changes in assumed retirement rates.

These changes from July 1, 2022 to July 1, 2024 are combined as follows:

## GASB 75 Results

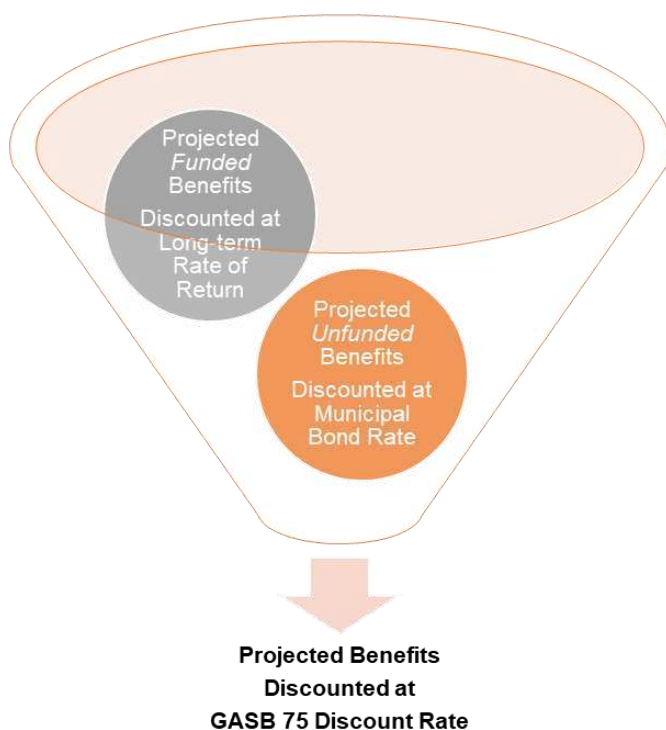
For financial reporting purposes, GASB 75 requires a discount rate that reflects the following:

- a. The long-term expected rate of return on OPEB plan investments – to the extent that the OPEB plan’s fiduciary net position is projected to be enough to make projected benefit payments and assets are expected to be invested using a strategy to achieve that return.
- b. A yield or index rate for 20-year, tax-exempt general obligation municipal bonds with an average rating of AA/Aa or higher – to the extent that the conditions in (a) are not met.

The amount of the plan’s projected fiduciary net position and the amount of projected benefit payments should be compared in each period of projected benefit payments.

Based on these requirements and the following information, we have determined a discount rate of 3.97% for GASB 75 reporting purposes:

### OPEB Expense

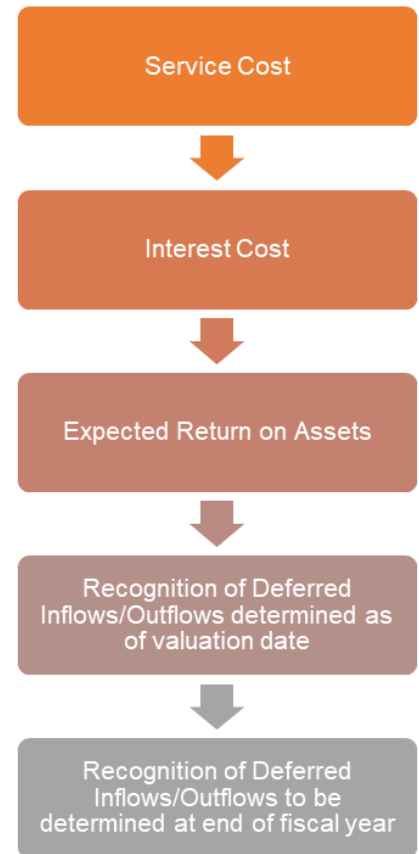
We have determined the following components of the District's OPEB Expense for the measurement year ending June 30, 2025: Service Cost, Interest Cost, Expected Return on Assets, and Deferred Outflows and Inflows (determined as of the valuation date).

- Service Cost represents the present value of benefits accruing in the current year.
- Interest Cost represents the interest on the Total OPEB Obligation and interest on the Service Cost.
- Expected Return on Assets is the expected return based on a 4.00% investment rate of return.
- Deferred Outflows and Inflows of Resources (determined as of the valuation date) are changes in the Net OPEB Liability resulting from differences between projected and actual plan experience, from differences between projected and actual OPEB plan investments, and from changes in assumptions.

The OPEB Expense will reflect additional Deferred Outflows and Inflows that will be determined based on the Net OPEB Obligation as of June 30, 2025.

We summarize results in the table on Page 10 of this report. For comparative purposes, we provide service cost and interest cost at three discount rates (the expected return on assets, the municipal bond index, and the GASB 75 rate, discussed above). We determine Deferred Outflows and Inflows solely on the applicable GASB 75 rate. All amounts are net of expected future retiree contributions, if any.

We will be available to assist the District and its auditors in preparing the footnotes and required supplemental information for compliance with GASB 75 (and GASB 74, if applicable). In the meantime, we are available to answer any questions the District may have concerning the report.





## **GASB 75 Results (continued)**

### **Actuarially Determined Contribution and Pay-As-You-Go with Implied Subsidy**

We have calculated an actuarially determined contribution representing the Service Cost and a 15-year amortization (as a level percent of pay) of the Net OPEB Liability. We include the results in the table on the next page. We provide results at three discount rates (the expected long-term expected return on assets, the municipal bond index, and the GASB 75 rate).

An actuarially determined contribution is a potential payment to the plan determined using a contribution allocation procedure. It is not a required contribution, but a measurement commonly used to prefund OPEB benefits. We provide the amounts for illustrative purposes.

The actuarially determined contribution may be compared to the pay-as-you-go payment. The table shows the pay-as-you-go payment along with the projected implied subsidy payment.

The Funding Schedules section provides additional prefunding alternatives.

## Funding Schedules

There are many ways to approach the pre-funding of retiree healthcare benefits. In the sections above, we determined the annual expense for all District-paid benefits. The expense is an orderly methodology, developed by the GASB, to account for retiree healthcare benefits. However, the GASB 75 expense has no direct relation to amounts the District may set aside to pre-fund healthcare benefits.

The table on the next page provides the District with three alternative schedules for funding (as contrasted with expensing) retiree healthcare benefits. The schedules all assume that the retiree fund earns, or is otherwise credited with, 4.00% per annum on its investments, a starting Trust value of \$0 as of July 1, 2024, and that contributions and benefits are paid mid-year.

The schedules are:

1. A level contribution amount for the next 20 years.
2. A level percent of the Unfunded Accrued Liability.
3. A constant percentage (3.00%) increase for the next 20 years.

We provide these funding schedules to give the District a sense of the various alternatives available to it to pre-fund its retiree healthcare obligation. The three funding schedules are simply three different examples of how the District may choose to spread its costs.

By comparing the schedules, you can see the effect that early pre-funding has on the total amount the District will eventually have to pay. Because of investment earnings on fund assets, the earlier contributions are made, the less the District will have to pay in the long run. Of course, the advantages of pre-funding will have to be weighed against other uses of the money.

The table on the following page shows the required annual outlay under the pay-as-you-go method and each of the above schedules. **The three funding schedules include the "pay-as-you-go" costs; therefore, the amount of pre-funding is the excess over the "pay-as-you-go" amount.**

### **Treatment of Implicit Subsidy**

We exclude any implicit subsidy from these funding schedules because we do not recommend that the District pre-fund for the full age-adjusted costs reflected in the liabilities shown in the first section of this report. If the District's premium structure changes in the future to explicitly charge under-age 65 retirees for the full actuarial cost of their benefits, this change will be offset by a lowering of the active employee rates (all else remaining equal), resulting in a direct reduction in District operating expenses on behalf of active employees from that point forward. For this reason, among others, we believe that pre-funding of the full GASB liability would be redundant.

The table below provides an alternative comparison of the funding schedules. The present value (or time-value) of payments for each alternative is \$756,767,737 and is equal to the excess of the present value of projected pay-as-you-go payments over any current trust/fund.

The difference between the sum of the contributions and the present value of contributions is the total interest cost associated with each alternative. As discussed above, the advantages of pre-funding should be weighed against other financial considerations.

## Plan Provisions

*Plan administration.* The District's governing board administers the Postemployment Benefits Plan (the Plan), which is a single employer defined benefit used to provide postemployment benefits other than benefits (OPEB) for eligible retirees and their spouses.

*Benefits provided.* The Plan provides lifetime postemployment benefits to eligible certificated and classified retirees and their spouses. To qualify, employees hired prior to August 31, 2007 (June 30, 2013 for CSEA members), must have 15 benefited service years with the District and attained the age of 55. Employees hired after September 1, 2007 (July 1, 2013 for CSEA members), must have 30 benefited service years with the District and attained the age of 55. Dental and vision benefits are provided for five years, but not beyond age 65. The District's governing board has the authority to establish and amend the benefits terms as contained within the negotiated labor agreements.

*Contributions.* The District charges its retirees for any District-paid medical/Rx claims on behalf of its retirees and their dependents that exceed ten percent (10%) of the total claims paid (for active employees plus retirees) in any fiscal year. Charges are assessed to all retirees in 12-equal payments from August through July of the following year.

## Actuarial Certification

The results set forth in this report are based on our actuarial valuation of the health and welfare benefit plans of the Clovis Unified School District ("District") as of July 1, 2024.

The valuation was performed in accordance with generally accepted actuarial principles and practices. We relied on census data for active employees and retirees provided to us by the District. We also made use of claims, premium, expense, and enrollment data, and copies of relevant sections of healthcare documents provided to us by the District, and (when applicable) trust statements prepared by the trustee and provided to us by the District.

The assumptions used in performing the valuation, as summarized in this report, and the results based thereupon, represent our best estimate of the actuarial costs of the program under GASB 74 and GASB 75, and the existing and proposed Actuarial Standards of Practice for measuring post-retirement healthcare benefits.

Throughout the report, we have used unrounded numbers, because rounding and the reconciliation of the rounded results would add an additional, and in our opinion unnecessary, layer of complexity to the valuation process. By our publishing of unrounded results, no implication is made as to the degree of precision inherent in those results. Clients and their auditors should use their own judgment as to the desirability of rounding when transferring the results of this valuation report to the clients' financial statements.

**RECOMMENDATION:**

Approve the participation of students from Buchanan, Clovis, Clovis East, Clovis North, Clovis Online and Clovis West high schools in the Concurrent Public Higher Education Program for the first semester of the 2024-25 school year, as submitted.

**DISCUSSION:**

Section 4880 of the California Education Code allows governing boards of school districts to authorize students to attend public higher education classes if students would benefit from the advanced scholastic or vocational training offered by public community colleges. School districts receive full Average Daily Attendance (ADA) credit for students participating in the program if the student attends his/her regular high school for at least 240 minutes per day or receives  $\frac{3}{4}$  of a full ADA if the student participating in this program attends their regular high school for at least 180 minutes per day.

Students at Buchanan, Clovis, Clovis East, Clovis North, Clovis Online and Clovis West high schools have participated in this program for the past several years. For the District to claim this additional ADA, audit forms will be required to verify that all students participating in the concurrent public higher education program summarized above are approved by the Governing Board.

The 2024-25 first semester concurrent enrollment at the District's five comprehensive high schools and Clovis Online School is as follows:

### **RECOMMENDATION:**

Approve a one-time retroactive payment to all eligible employees and retirees for the observance of the federal Juneteenth holiday in 2021 and 2022.

### **DISCUSSION:**

In 2021, the President of the United States officially recognized Juneteenth as a federal holiday and in 2022, the Governor of California also recognized Juneteenth as a state holiday. This action was taken as part of a growing national acknowledgement of its importance. However, in the years 2021 and 2022, permanent-position employees whose regular work years encompassed June 19 did not receive the holiday benefit of time off or holiday compensation.

In an effort to address this loss of benefit in a consistent manner across the District, it is recommended that the Governing Board approve a one-time retroactive payment to all eligible employees and retirees whose regular work year spanned June 19th in 2021 and/or 2022. This payment addresses the missed holiday while also acknowledging their work and our District's commitment to equity and the honoring of all federally recognized holidays.

Because there is a current class action lawsuit by CSEA in motion (in which the District is named among others), restoration for CSEA represented employees will be based upon the settlement terms and process once the case is approved by the court.

### **FISCAL IMPACT:**

Fiscal impact is estimated to be less than \$350,000 per holiday totaling approximately \$700,000. That cost will be charged to the appropriate District funds.
