A New Job Title



This year, Clovis Unified officially changed our title to **School Counselor**, aligning with state and national standards. This change better reflects the comprehensive role counselors play in academic, college and career, and social-emotional support. It acknowledges our work as educators, advocates, and mental health professionals who collaborate with families, teachers, and administrators to ensure student success.

American School Counselor Association (ASCA) National Model

The School Counselor's Role

School counselors design and deliver school counseling programs that improve student outcomes. They lead, advocate and collaborate to promote equity and access for all students by connecting their school counseling program to the school's academic mission and school improvement plan. They uphold the ethical and professional standards of ASCA and promote the development of the school counseling program based on the following areas of the ASCA National Model: define, deliver, manage and assess.

School counselors create school counseling programs based on three sets of standards that define the profession. These standards help school counselors develop, implement and assess their school counseling program to improve student outcomes.

School counselors deliver developmentally appropriate activities and services directly to students or indirectly for students as a result of the school counselor's interaction with others.

These activities and services help students develop the ASCA Student Standards: Mindsets & Behaviors for Student Success and improve their achievement, attendance and discipline. Through the school counseling program, school counselors ensure equitable academic, career and social/emotional development opportunities for all students.

Direct Services with Students

Direct services are in-person interactions between school counselors and students and include the following:

- Appraisal and Advisement
- Counseling

Indirect Services for Students

Indirect services are provided on behalf of students as a result of the school counselors' interactions with others including:

- Consultation
- Collaboration
- Referrals

ASSESS

To achieve the best results for students, school counselors regularly assess their program to:

- determine its effectiveness in helping all students succeed
- inform improvements to their school counseling program design and delivery
- show how students are different as a result of the school counseling program

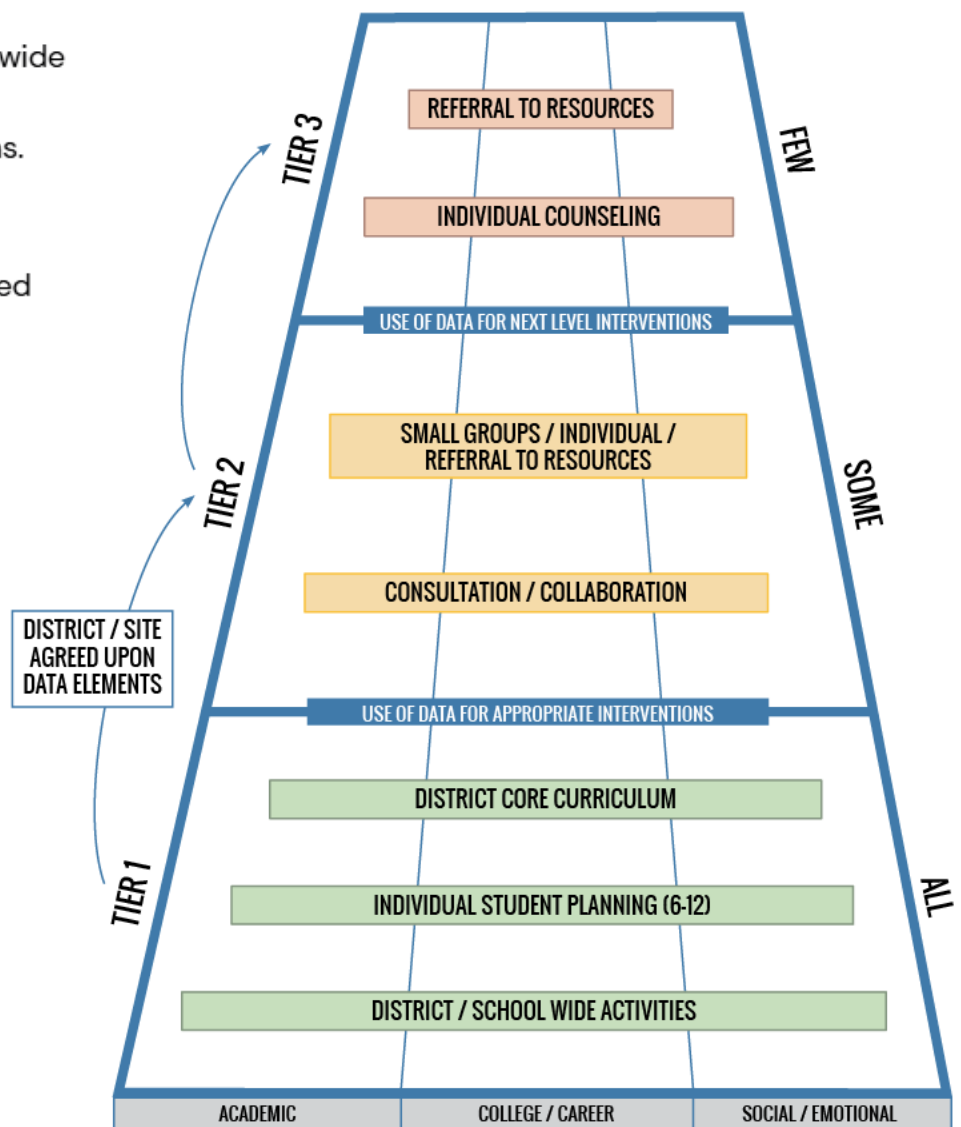
Developing Intentional Courses and Programs

Multi-Tiered, Multi-Domain System of Supports (MTMDSS)

School Counselors play a key role in the Multi-Tiered, Multi-Domain System of Supports (MTMDSS) ensuring students receive the appropriate level of intervention.

- **Tier 1** (Universal Supports): Schoolwide counseling curriculum, classroom lessons, and universal interventions.
- **Tier 2** (Targeted Supports): Small group counseling, check-ins, and interventions for students who need additional assistance.
- **Tier 3** (Intensive Supports): Individualized interventions for students requiring high levels of support.

MTMDSS builds on MTSS by expanding support beyond academics and behavior to include health, mental health, and wellness.



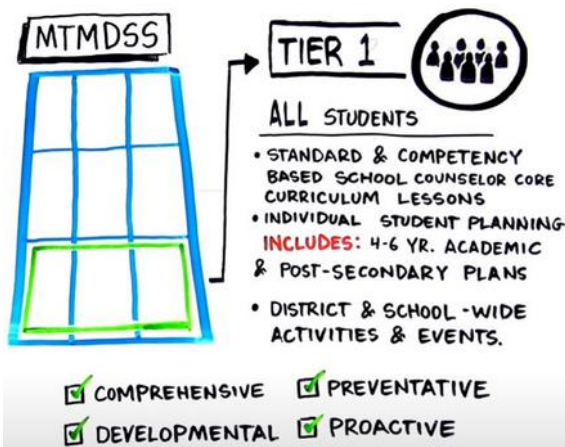

This year, School Counselors expanded Tier 1 services, developing CUSD-branded classroom lessons for grades nine through 12, with plans to extend to grades seven and eight in 2025–26. Lessons are data-driven, use pre/post-tests to measure student learning and align with the ASCA National Model for consistency across all sites. Counselors are in classrooms more than ever, reinforcing their commitment to student engagement with ALL students. Mid-year reports from all sites reflected these efforts and were shared during National School Counseling Week in February.

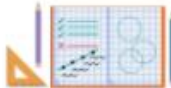

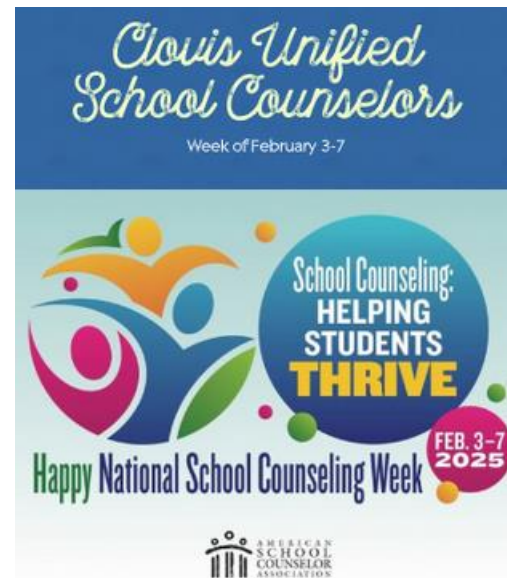

Why This is Important

- Ensure that all eligible students have access to financial aid opportunities for postsecondary education
- Access to federal, state and institutional aid
- Enrollment fees waived at community college for up to two years, regardless of income



Per Education Code 51225.7, all high school seniors in California must complete and submit the Free Application for Federal Student Aid (FAFSA) or California Dream Act Application (CADAA), or submit an Opt-Out Form. This requirement ensures all eligible students have access to financial aid, including two years of waived enrollment fees at community colleges, regardless of income. Clovis Unified's Race to Submit initiative has significantly increased FAFSA/CADAA completion rates, leading to greater financial aid access for students.

Earning College Credits in High School

Advanced Placement (AP)

AP courses offer a challenging and stimulating educational experience for college-bound students. In May, students take the corresponding AP exams, scored on a five-point scale. Most major college and universities recognize the scores of three, four or five and may award college equivalent credit. The amount and type of credit award varies by institution.



Concurrent Enrollment

Concurrent Enrollment: Students enrolled in a college course taught by a college instructor **not on a high school campus** and **receive both high school and college credits**.

Seniors in the Clovis Community College Advantage Program (CCCAP) earn 12 college units AND 20 high school elective credits through Clovis Community College.



Dual Enrollment

Dual Enrollment: Students enrolled in a CUSD high school course typically taught by a high school instructor **on a high school campus** and **receive both high school and college credit**.



Current Courses that receive Dual Enrollment/Dual Credit

- Career Technical Education (CTE) Courses are offered Dual Enrollment through Reedley College, Clovis Community College, Fresno City College and Butte College.
- CART has Dual Enrollment partnerships with local Community Colleges and Fresno State.
- Qualified students placed in Rhetoric and Composition at any of our high schools can receive English 1A credit from Clovis Community College.



Community College Enrichment

Enrichment: Students enrolled in community college classes that are **taught by a college instructor** online or on a college campus. Students receive **college credit only**.

Beginning the summer before the freshman year, students can take enrichment courses each semester (summer, fall, spring).

The CUSD IMPACT Program is part of a districtwide effort to support student achievement. Our founding superintendent, Dr. Floyd Buchanan, believed in a “A fair break for every kid.” We hold tightly to the belief that “ALL students can learn.” As an educational team, we want all students to reach their full potential in mind, body, and spirit. Our CUSD IMPACT Program allows us the opportunity to focus on students who might not seek support but would benefit from mentoring and increased connection to school resources. We provide ongoing support to students and families with the resources they need to be successful in the classroom, at home, and in the community. The main responsibility of CUSD IMPACT Teams is to ensure that all students achieve academic success and improve engagement and connectedness to school. IMPACT Team members collaborate with parents, staff, district administrators, and other educational partners to review and oversee individual progress of identified students to ensure they are college and/or career ready and engaged in and accessing the school system and all it has to offer our students. The IMPACT Teams provide support to students and families by ensuring equal access to education and connecting them to resources through building relationships.

STUDENT RELATIONS LIAISONS (SRLs) AND INSTRUCTIONAL ASSISTANTS (IAs) WORK WITH UNDER-SERVED STUDENTS

Members of the IMPACT Teams regularly monitor and communicate with school officials regarding academically at-risk students throughout the school year. Communication takes place between teachers, parents, and students to develop individual student plans for success at all grade levels. Team members coordinate efforts with teachers, counselors, administrators, and other IMPACT Team leaders. SRLs, and IAs provide support when needed for parents and guardians to fully engage in Student Study Team (SST), 504 meetings, School Attendance Review Board (SARB), Student Transition and Re-entry (STAR), and other meetings pertaining to their student’s academic success. Team members assist certificated teachers with the presentation of learning materials and instructional exercises. In addition, they assist teaching staff in conducting lessons, classroom activities, and cultivation of classroom projects. Our teams work with individual or small groups of students reinforcing instructions given by teachers in reading, math, and other subjects. Members of the IMPACT Teams are responsible for the following:

- Observing and monitoring behavior of students according to approved procedures
- Reporting progress regarding students’ performance and behavior
- Maintaining positive behavior among students in the classroom and on the school grounds
- Supervising students at various school-wide activities such as field trips
- Serving as role models
- Providing emotional support, a friendly attitude, and general guidance
- Assuring the health and safety of students

CUSD IMPACT RESOURCE CENTERS AND PARENT/GUARDIAN SUPPORT

When families partner with schools, teachers, and the community, we know their children succeed academically. True to CUSD’s Mission, to be a quality educational system providing resources for ALL students to reach their potential in mind, body, and spirit. Our Resource Centers are designed to educate students, parents, and guardians on how to foster a positive partnership with the school sites to best support academic success. Our aim is to provide strategies to support, advocate, and empower members of the school community to engage fully in the educational lives of students and connect those with resources beneficial to all students. In-person meetings with students utilize lessons on organizational skills, study skills, goal setting, and progress monitoring.

The IMPACT Transition Teams, in partnership with Curriculum, Instruction, and Accountability, provide training and support at monthly Parent Information Nights. Topics include: the importance of parents being involved in their children’s education, effective strategies for parent involvement, the role of the parent and of the teacher in influencing student performance, parent-teacher interaction at conferences, social media awareness, substance abuse issues, resources for newcomer and immigrant families, student safety, and college and career readiness. By participating in a variety of activities and lessons, parents and guardians increase their knowledge about the opportunities available to their students to help guide them through their educational journey and lead them to be college and career ready.

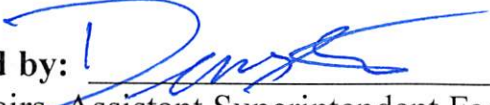

Authorize Clovis Unified School District to enter into a three-year agreement with San Joaquin County Office of Education for use of its Special Education Information System (SEIS), a web-based suite of Individualized Education Program (IEP) management tools for the 2025-26, 2026-27, and 2027-28 school years.

DISCUSSION:

SEIS is a web-based system that Clovis Unified has utilized since 2013 for managing special education data. Its features include IEP writing, service tracking, CALPADS reporting, and integration with student information systems (SIS), all aimed at maximizing efficiency and accuracy.

FISCAL IMPACT:

The cost for this agreement is \$208,189.50 for three years, or \$69,396.50 per year, and is included in the Special Education Budget. This reflects an increase from the previous agreement, which was \$150,156 over three years.

Authorize the Superintendent or designee to enter into an agreement with Medical Billing Technologies (MBT), as submitted.

DISCUSSION:

The Local Educational Agency (LEA) Medi-Cal Direct Billing Option enables school districts to receive reimbursement for providing eligible health and mental health screenings, assessments, and treatments to students enrolled in Medi-Cal. Given the complexity of the program, the District partners with a third-party administrator to ensure compliance and maximize reimbursements.

For the past six (6) years, the District has partnered with MBT as its third-party administrator. During this time, the District has experienced a substantial increase in reimbursements through the LEA Medi-Cal Direct Billing program. In the 2023-24 fiscal year, the District received \$3.6 million in reimbursements, with projections indicating this amount will increase to \$4 million for 2024-25.

In recognition of the significant financial impact and effective support provided by MBT, Administration recommends the Board authorize a five-year contract renewal with MBT, from July 1, 2025, through June 30, 2030.

FISCAL IMPACT:

The District will pay an annual lump sum of \$110,000. At the conclusion of each fiscal year and once Medi-Cal reimbursements have been reconciled, MBT will issue a final invoice for 6% of total reimbursements received by the District, less the lump sum payment, for an amount not to exceed \$220,000. The service provided by MBT will generate an estimated \$4 million in reimbursement revenues for the District annually.
