





RECOMMENDATION:

The annual report for both Clovis Unified School District and Fresno County Williams Visitation is being provided for Governing Board review.

DISCUSSION:

As a result of the 2004 settlement of Eliezer Williams, et al. vs the State of California, et al. (Williams), a package of legislation often referred to as the Williams legislation was passed to ensure that all students have access to a quality education. As a result, all schools are required to ensure that every student has access to textbooks, and safe and clean school facilities.

Additionally, county offices of education are required to annually monitor identified schools to verify textbook sufficiency, safe and clean school facilities, and accurate School Accountability Report Card (SARC) reporting and annually report to districts a summary of the findings.

Key findings and overall compliance for Clovis Unified and Fresno County are:

- Instructional materials: All schools have sufficient, standards-aligned textbooks and resources.
- Facilities: All facilities are in good repair, no emergency conditions identified.
- SARCs: Accurate reporting across all districts.
- Teacher misassignments/vacancies: Not included in Williams reviews; tracked separately by the California Department of Education (CDE).

Williams Settlement Legislation

Annual Report for Fresno County Schools – 2025-2026 Academic Year (Monitored Fall 2025)

This report summarizes the results of the 2025 Williams Settlement site visits and documentation reviews conducted across Fresno County schools identified by the California State Superintendent of Public Instruction.

Pursuant to Education Code Section 1240 (2)(A)(i), the County Superintendent of Schools is required to report the results of these annual reviews to the governing boards of all school districts under the county's jurisdiction. This submission ensures transparency and public accountability regarding the condition of instructional materials, facilities, and school reporting accuracy.

The annual Williams monitoring process focuses on three mandated areas:

- 1. Instructional Materials
- 2. School Facilities
- 3. School Accountability Report Cards (SARCs)

Teacher misassignments and vacancies are not part of the Williams site review process. These data are collected and reported separately by the California Department of Education (CDE) through the annual Teacher Misassignment & Monitoring Outcome data system.

Instructional Materials

- All schools reviewed during Fall 2025 were found to have sufficient textbooks and instructional materials across the four core subject areas—English Language Arts, Mathematics, Science, and History–Social Science.
- "Sufficient" means every pupil, including English Learners, had access to a standardsaligned textbook or instructional material for classroom and home use.
- Reviews also confirmed adequate instructional materials in foreign language and health for middle and high schools and laboratory science equipment for grades 9–12.
- No deficiencies were identified in any of the classrooms visited throughout Fresno County's participating districts.

Summary

The 2025 review found all schools compliant with Williams standards for textbook sufficiency. Each student had equitable access to current, standards-aligned materials.

School Facilities

- Facility inspections determined whether campuses were in "good repair" and whether any posed "emergency conditions"—defined as threats to the health or safety of students or staff.
- All schools reviewed were rated either Good or Exemplary, and no emergency deficiencies were identified at any site.
- Minor repair items observed (e.g., flooring, lighting, or HVAC adjustments) were routine maintenance issues and were corrected promptly.

Summary

Fresno County schools demonstrated strong compliance with state facility requirements. Buildings and grounds were safe, clean, and functional, ensuring environments conducive to student learning.

School Accountability Report Cards (SARCs)

- The February 1, 2025 SARCs were reviewed for accuracy in reporting on instructional materials sufficiency and facility conditions.
- All schools across the county reported no discrepancies between site visit findings and their published SARCs.
- The results confirm that districts are maintaining accurate, transparent public reporting as required by state law.

Summary

Every school's SARC accurately reflected site conditions, showing alignment between on-site findings and public accountability documentation.

Teacher Misassignments and Vacancies (Reported Separately)

While referenced in the Williams Settlement legislation, these data are not collected through the Williams review visits. Instead, the CDE's Teacher Misassignment & Monitoring Outcome reporting system verifies that teachers hold appropriate credentials and authorizations, including those required for serving English Learners, and that all classes are staffed with permanent instructors beyond the first 20 days of the school year.

Key Findings and Overall Compliance

- Instructional Materials: All schools met sufficiency requirements; no shortages identified.
- Facilities: All campuses rated Good or Exemplary; no emergency conditions found.
- SARCs: Fully accurate and compliant with state reporting standards.
- Teacher Misassignments/Vacancies: Not part of the Williams review; reported separately through CDE monitoring.

The 2025 Williams Settlement monitoring demonstrates full compliance by Fresno County schools in all reviewed areas. Students had equitable access to instructional materials, learned in safe and well-maintained facilities, and were represented accurately through publicly reported SARCs. Staffing compliance is verified through CDE's statewide teacher assignment monitoring process.

These results reflect Fresno County's ongoing commitment to upholding educational equity, safety, and transparency for all students and school communities.

2025-26 Williams Monitoring District Summary Report Clovis Unified School District

Introduction

The Fresno County Superintendent of Schools (FCSS) office annually monitors identified schools as required by the Williams legislation. FCSS is committed to partnering with our districts and schools to ensure that every student has access to textbooks, safe and clean facilities, and qualified teachers.

Background

As a result of the 2004 settlement of *Eliezer Williams*, et al. vs the State of California, et al. (Williams), a package of legislation often referred to as the Williams legislation was passed to ensure that all students had access to a quality education. As a result, all schools are required to ensure that every student has access to textbooks and safe and clean school facilities.

Additionally, county offices of education are required to annually monitor identified schools to verify textbook sufficiency, safe and clean school facilities, and accurate SARC reporting and annually report to districts a summary of the findings.

Clovis Unified Summary of Findings

The Williams Monitoring District Summary Report provides a summary of the findings from all visits conducted at Clovis Unified for the Williams monitoring period. This report includes findings from 13 schools for instructional materials, facilities, and SARC reporting.

Facilities

FCSS conducted inspections of 13 school facilities in Clovis Unified.

The Facility Inspection Tool (FIT) was used to determine the condition of the school facilities. School facilities ratings are calculated as a percentage of deficiencies findings and assigned a "Good" or "Exemplary" rating.

Schools with a "Fair" or "Poor" rating have an opportunity to correct the deficiencies and have a follow-up inspection. The results of the follow-up inspection are reported in the summary of findings.

Any school with an "emergency" condition-a deficiency that poses a threat to the health or safety of pupils and staff while at the school—must be corrected immediately and a follow-up inspection is required. The revised rating is reflected in the summary of findings.

- 10 schools in "Exemplary" condition
- 3 school in "Good" condition
- o schools in "Fair" condition
- o schools in "Poor" condition

Textbook Sufficiency

FCSS reviewed 13 schools for textbook sufficiency in English-language arts, English-language development (ELD), history-social science, math, science, world (foreign) language, and health education. Science laboratory equipment sufficiency for grades 9-12 was also reviewed.

13 schools of 13 schools (100%) reviewed were found to meet textbook sufficiency standards.

School Accountability Report Card (SARC)

Schools are required to annually update their School Accountability Report Card (SARC). William's legislation requires schools to report accurately on any maintenance to ensure "good repair" of the facilities and on the sufficiency of textbooks and instructional materials.

As required by William's legislation, FCSS reviewed all SARCs to verify that schools provided accurate reporting in the areas of textbook sufficiency and facilities maintenance for the SARC published during the 2024-25 school year.

DISCUSSION:

On June 11, 2025, the Governing Board approved the adoption of mCLASS DIBELS by Amplify Education as the District's K-2 reading risk screener. Since implementation, the tool has provided valuable, actionable data to help teachers identify reading challenges and tailor targeted instruction.

Teachers in grades 3–6 have expressed strong interest in using mCLASS DIBELS to support students who continue to face reading difficulties beyond the primary grades. Expanding access will enhance progress monitoring, enable timely interventions, and promote literacy growth across all elementary grades.

Amplify Education has offered Clovis Unified School District the same per-student pricing for grades 3–6 as originally contracted for K–2, guaranteed for three years. The proposal includes 3,500 student licenses (approximately 100 per elementary site) for use with at-risk students. Licenses are transferable throughout the three-year term, allowing reassignment if a student exits intervention or leaves the District.

FISCAL IMPACT:

Not to exceed a one-time cost of \$85,000 for training, resources, and access to the mCLASS DIBELS platform for a three-year period (2025-26, 2026-27, and 2027-28 school years). The expenditure will be funded through the Educator Effectiveness Funds Grant.

DISCUSSION:

The PIP is available when the employing agency knows that there will be a teacher vacancy yet is unable to recruit a suitable candidate. The expectations of the employer and the employee are higher since this individual will be the teacher of record and should be on a credential track. The focus of the document is meeting subject matter competency. Once a candidate completes subject matter competency, the candidate can be employed on a document such as a District Internship Credential. Candidate requirements include the following: (1) Bachelor's degree or higher; (2) passage of the California Basic Educational Skills Test (CBEST); and (3) specific course work or experience, explained in detail on the PIP information leaflet.

As required by the California Commission on Teacher Credentialing (CCTC), employing agencies offering employment to a candidate on a PIP are required to: (1) conduct a diligent search for a suitable credentialed teacher or qualified internship teacher; (2) provide the PIP holder with orientation, guidance, and assistance as specified in Title 5 Section 80026.5 of the California Code of Regulations; (3) assist the PIP holder in developing a personalized plan (kept on file at the local level) through an agency-defined assessment leading to completion of subject matter competence; and (4) counsel the PIP holder to enroll in subject matter training. Clovis Unified School District administration hereby declares that a diligent search was conducted for suitable credentialed teachers or qualified internship teachers. Upon Board approval, District administration asserts that steps 2-4, as outlined above, will be completed.

School districts submitting PIP requests must include verification that a notice of intent to employ the applicant(s) in the identified positions was made public. The public notice must include the following information: (1) the name of the applicant(s); (2) the assignment in which the applicant(s) will be employed including subject(s), grade level(s), and school site; and (3) a statement that the applicant(s) will be employed on the basis of a PIP. Clovis Unified intends to submit a PIP request for the following teacher candidate(s), contingent upon administration and Board approval:

EXECUTIVE SUMMARY

Under Education Code 17620 et seq., school districts may levy fees ("School Fees") in order to offset the impacts to school facilities from new residential and commercial development. Commencing January 1, 1987, statutory school fees were authorized to be levied in the amount of \$1.50 per square foot of new residential assessable space and \$0.25 per square foot of enclosed commercial or industrial assessable space ("Level 1 Fees"), and are subject to an increase of the statutory fees based on the Statewide cost index for Class B construction, as determined by the State Allocation Board every two years. With the passage of Senate Bill 50 (the Leroy F. Greene School Facilities Act) in 1998, the State School Facility Program was established and provides school districts with the option of adopting alternative school fees (also known as "Level II Fees" and "Level III Fees") in excess of the Level I Fee upon meeting certain requirements and are valid for a maximum of one (1) year.

In accordance with Government Code Sections 66001 and 66006, Clovis Unified School District ("School District") must provide certain information on an annual and five-year basis regarding the collection and expenditure of School Fees collected under the authorization of Education Code Section 17620 et seq and Government Code Section 65995 et seq. For the purposes of annual and five-year reporting requirements, the collection of School Fees does not include letters of credit and bond proceeds secured by payment of School Fees at a future date; revenues from developments under special mitigation agreements; or any other financing instrument used by the School District to fund school facilities construction and improvements.

The School District last published a report covering five-year reporting requirements (as defined under Government Code Section 66001(d)(1)) after the end of Fiscal Year ("FY") 2020-21 and will not be required to publish relevant reporting until 180 days after the end of FY 2025-26. Hence, the following information addresses only annual reporting requirements specified by Government Code Sections 66001 and 66006.

ANNUAL REPORTING REQUIREMENTS

This report contains certain information regarding the type, amount, collection and expenditure of School Fees for FY 2024-25. Each of the capitalized letters A-H below corresponds to the specific letter and portion of Government Code 66006.

A. Type of Fee

Clovis Unified collects both Level I Fees and Level II Fees. Level I Fees are collected pursuant to Sections 17620 et seq. of the Education Code and Sections 66001 and 65995 et seq. of the Government Code. School Fees are deposited into the Capital Facilities Fund, Fund 25. Level I Fees are levied on square footage of assessable space for commercial/industrial construction/reconstruction and residential construction/reconstruction (primarily residential additions). Additionally, pursuant to Sections 65995.5, 65995.6, and 65995.7 of the Government Code, the School District collected Level II Fees.

B. Amount of Fee

For collection purposes, all unmitigated residential construction/reconstruction in the School District was subject to School Fees in the amounts set forth in the table below.
