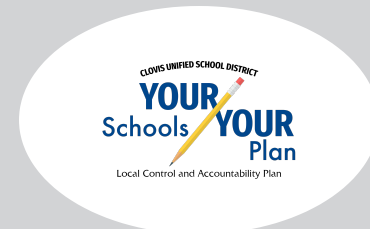

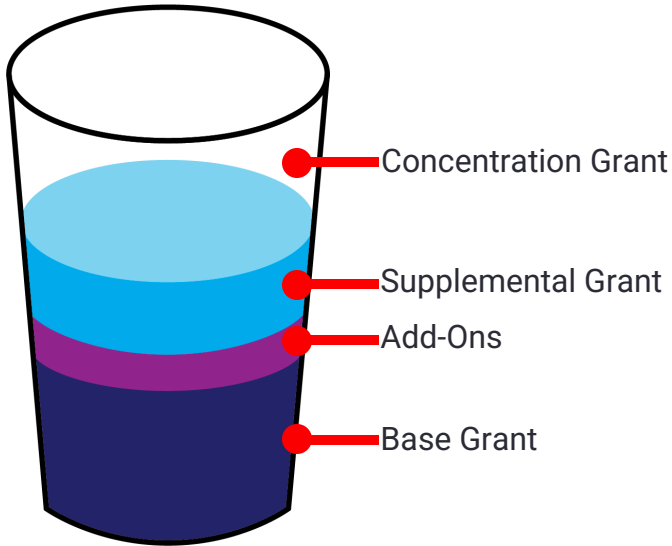


What is LCAP?

A three-year plan that is revised and adopted annually and describes how **the District's** allotment from **California's Local Control Funding Formula (LCFF)** will be used. Clovis Unified's Local Control Accountability Plan (LCAP) pairs educational partners' (**students, parents, employees, and the community**) feedback with proven learning strategies to create an action plan of services primarily supporting **English learners (EL), foster youth (FY), and low-income (LI) students.**

Concentration Grant \$0

Additional funds given to any school district whose percentage of qualifying students (EL, FY, and LI) exceeds 55%

Supplemental Grant \$44,986,615

Supplemental Grant based on the District's number of unduplicated EL, FY, and LI students

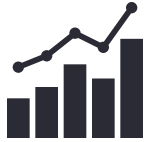

Understanding the LCAP "Three-Year Cycle"

2023-24 This was Year 3 of our previous three-year LCAP cycle and the year we drafted our next three-year cycle. When developing a new LCAP cycle, we are required to use baseline data to set desired outcomes for each metric.

During the drafting period in Spring 2024, the baseline data for **California Dashboard indicators come from the 2022-23 school year**, as those are the most recent available scores. These scores serve as a reference point for measuring progress in the first year of the new plan's implementation. Examples of California Dashboard indicators:

- Smarter Balanced Assessment Consortium (SBAC) English Language Arts (ELA)
- SBAC Math
- College Career Indicator (A-G Completion)
- Chronic Absenteeism
- Suspension Rate

Baseline data for **local indicators are from the 2023-24 school year**, as we are able to gather the results during the 2023-24 school year. Examples include:

- Local ELA Assessment
- Local Math Assessment
- Parent Overall Connectedness to School
- Staff Overall Connectedness to School
- Student Overall Connectedness to School
- Percent Earning Healthy Fitness Zone

For the **Smarter Balanced ELA Met or Exceeded** metric:

- All students increased 0.7%, we need to grow 2.2% to meet our desired outcome of 70% in the 2026-27 school year
- EL decreased 7.1%, we need to grow 7.8% to meet our desired outcome of 23% in the 2026-27 school year
- LI decreased 1%, we need to grow 1% to meet our desired outcome of 56% in the 2026-27 school year
- FY decreased 6.8%, we need to grow 1.3% to meet our desired outcome of 21% in the 2026-27 school year
- LTEL decreased 1%, we need to grow 3.4% to meet our desired outcome of 17.2% in the 2026-27 school year

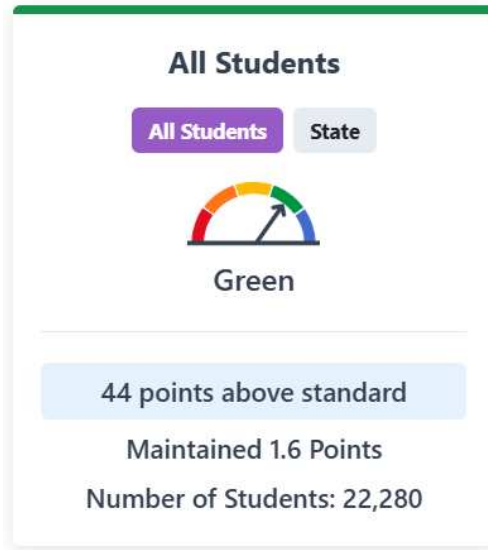

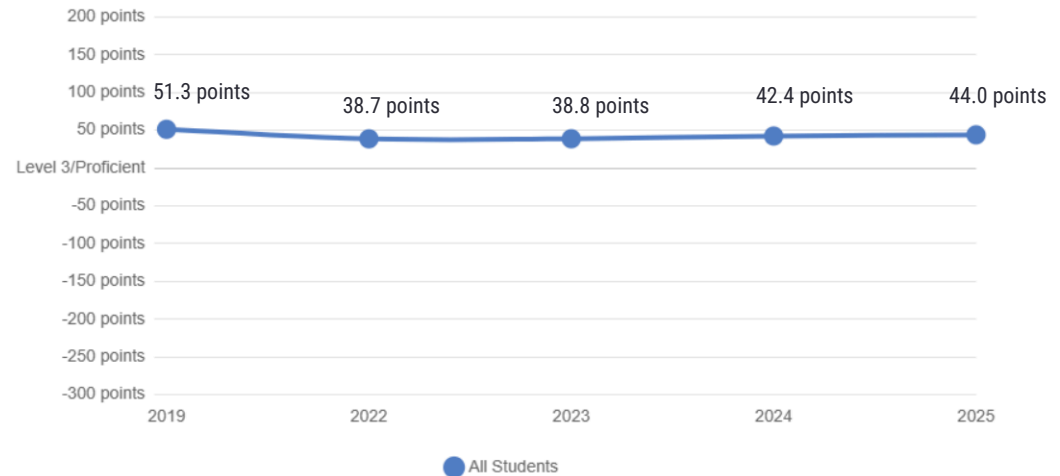

Understanding "Distance from Standard" (DFS) for the SBAC

ELA



DFS measures how far, on average, students are from the lowest possible score for Level 3/Proficient. The Smarter Balanced Consortium has identified Level 3/Proficient as demonstrating the knowledge and skills necessary for students to be on track for college and career readiness at their grade level.

Analyzing and Understanding the Table for "Distance from Standard"

For the **Smarter Balanced ELA DFS metric**:

- All students moved 1.6 points more above standard, we need to grow 3.8 points to meet our desired outcome of 47.9 in the 2026-27 school year
- EL moved 6.6 points more toward standard, we need to grow 1.1 more toward standard to meet our desired outcome of -4.9 in the 2026-27 school year
- LI moved 2.3 points more above standard, we need to grow 4.7 more above standard to meet our desired outcome of 16.9 in the 2026-27 school year
- FY moved 2.2 points more toward standard, we need to grow 21.5 more toward standard to meet our desired outcome of -44.5 in the 2026-27 school year
- *These were the minimum points necessary to move up to the next color in the performance levels on the California Dashboard.*

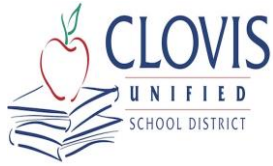

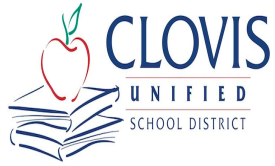

Section 48800 of the California Education Code allows school district governing boards to authorize students to attend public higher education classes if students would benefit from the advanced scholastic or vocational training offered by public community colleges. School districts receive full Average Daily Attendance (ADA) credit for students participating in the program if the student attends his/her regular high school for at least 240 minutes per day or receives $\frac{3}{4}$ of a full ADA if the student participating in this program attends their regular high school for at least 180 minutes per day.

Students at Buchanan, Clovis, Clovis East, Clovis North, Clovis Online and Clovis West high schools have participated in this program for the past several years. For the District to claim this additional ADA, audit forms will be required to verify that all students participating in the Concurrent Public Higher Education Program summarized above are approved by the Governing Board.

Summary:

Under the general direction of the Director of Visual and Performing Arts, the Instrument Repair Specialist performs evaluation, repairs, setups, maintenance, and distribution of brass, wind, string, and percussion instruments to student musicians, and performs related work as required. This position provides the school community with support in providing a quality arts program that directly supports student learning and achievement.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Cares for and maintains tools, equipment, and shop areas.
- Communicates with other departments, students, staff, and outside agencies to exchange information, coordinate activities, and resolve issues; performs emergency instrumental repairs as requested.
- Dismantles and reassembles musical instruments; removes keys, rods, corks, pads, and valves; cleans keys, hinges, tubes, rods, and bodies of instruments; replaces and fits keys, pads, cork felts, and heads; aligns valves and straightens slides; resets bridges and repairs bows; determines salvageability of damaged instruments; creates new parts for obsolete instruments.
- Maintains inventory of parts and supplies, and orders replacement inventory when necessary.
- Maintains records, provides reports, and records work data; utilizes an online inventory management system to ensure the availability of sufficient inventory and keeps track of assets. Operates within a defined budget.
- Maintains work site and storage areas in a clean and orderly condition, protecting building occupants from work site hazards.
- May participate in or provide services for production areas beyond instrument repair, including the operation of production equipment during production.
- Performs skilled and semi-skilled work in connection with the maintenance, repair, and improvement of musical instruments and equipment, including a variety of brass, woodwind, string, and percussion instruments and cases.
- Picks up and delivers instruments to various locations.
- Provides guidance to students and staff regarding the proper operation, care, and storage of instruments; serves as a resource to district staff, students, and others regarding instruments and instrument repair.
- Removes dents; chemically cleans brass and woodwind instruments, including acid washings; polishes and buffs instruments.
- Uses standardized industry procedures.
- Sanitizes instruments after use so they can be distributed to new students.
- Supervises and schedules non-contracted staff, including students.

LICENSE(S) and CERTIFICATIONS REQUIRED: Valid current California Driver's License. Completion of a certified instrument repair program or equivalent is preferred but not required. Pass the District's applicable proficiency exam for the job class with a satisfactory score.

WORK ENVIRONMENT/ PHYSICAL DEMANDS: Work is performed indoors in a shop environment and occasionally outdoors where safety considerations exist from physical labor and working with or in the vicinity of electrical connections and tools. RECOMMENDATION:

Approve the Memorandum of Understanding (MOU) to adjust the longevity pay amount effective July 1, 2025, and the Professional Growth program ensuring compliance with Public Employees' Retirement Law (PERL) and California Public Employees' Retirement System (CalPERS) regulations.

DISCUSSION:

The District is actively working with CalPERS to address compliance requirements related to special compensation categories, specifically longevity and Professional Growth Pay.

The District applies Board-approved salary schedule increases to classified employees' longevity pay. To be compliant, each time the longevity amount is adjusted, an MOU must be established. Approving this MOU for the period effective July 1, 2025, will ensure that our employees' retirement benefits accurately reflect their longevity pay and it is creditable toward their retirement incentive.

Professional Growth Pay is another form of special compensation available to employees hired before July 1, 2006. This program was created to support classified employees in advancing their skills and knowledge within their career paths. The MOU for Professional Growth Pay will secure this compensation as part of the retirement incentive calculation for eligible employees.

This Tentative Agreement is entered into by the California School Employees Association and its Clovis Chapter 250 (together "CSEA") and the Clovis Unified School District ("District"), collectively "the Parties."

The Parties wish to resolve negotiations for the 2025-2026 school year and to resolve the remaining issues from Public Employment Relations Board ("PERB") Decision No. 2946. Therefore, the Parties agree as follows:

1. **Article 12: Compensation**

Salaries

Effective July 1, 2025, CSEA bargaining unit members will receive a three and one half percent (3.5%) increase to the Classified Operations Unit salary schedule for the 2025-2026 school year. If any other employee group receives more than a 3.5% increase to its salary schedule for the 2025-2026 school year, CSEA bargaining unit members will receive the equivalent of the highest percentage increase provided to another employee group. Any increase to the Classified Operations Unit salary schedule will not include adjustments from items such as reclassifications, classification studies, or market studies.

The District will grant all voting eligible bargaining unit members one (1) hour of release time for the purpose of voting on the CBA ratification.

2. **Article 10: Safety**

The Parties agree that the District will follow OSHA requirements regarding working conditions exacerbated by weather. Except as set forth above, all other terms and conditions as set forth in the parties 2023-2026 collective bargaining agreement shall remain status quo.

3. **PERB Decision No. 2946**

The Parties wish to resolve all remaining issues resulting from PERB Decision No. 2946. Specifically, the Parties wish to resolve all compliance issues resulting from Decision No. 2946. Therefore, the Parties agree as follows:

A. As a result of the District's classification study, effective July 1, 2025, the compensation of Transportation Vehicle Mechanic I has been adjusted to Grade 25, Transportation Vehicle Mechanic II has been adjusted to a Grade 29, and Transportation Vehicle Service Worker I has been adjusted to Grade 15. Based on these three

adjustments, the Parties agree no further negotiations on the salary grades of these three positions is necessary and that the issue is fully resolved.

B. The Parties agree there are no additional bargaining costs or interest owed by District to CSEA resulting from Decision No. 2946 and that this issue is fully resolved.

C. The Parties agree that in all respects the District has complied with the Order in PERB Decision No. 2946 and that all issues resulting from that decision are fully resolved.

This Agreement shall be effective on the date of execution by the parties, or, if ratification is necessary based on the internal procedures of either party, as of the date of ratification.

RECOMMENDATION:

A recommendation for a financing agreement to fund the 2026-27 employee computer refresh program will be brought to the Governing Board for action at a future date.

DISCUSSION:

The District established the computer refresh program in the 2004-05 school year and has maintained the program annually since that time. From the 2020-21 through 2025-26 school years, the program was funded using one-time State funds, which have now been fully expended.

To continue the computer refresh program, the District is proposing a four-year lease agreement with a \$1.00 buyout option at the conclusion of the lease term, consistent with the funding approach used prior to the availability of one-time State funds. Under this model, equipment is assigned to staff for four years and subsequently redeployed to school sites for student use for an additional two years.

This item will appear on the March 18, 2026, consent agenda.

FISCAL IMPACT:

The amount financed will be \$2,500,000 for the purchase of approximately 1,400 computers. The fiscal impact will be presented to the Board at the time action is taken on the bid results.

RECOMMENDATION:

Adopt Resolution No. 4082 regarding the annual Self-Certifying Increased Federal Micro-Purchase Threshold pursuant to 2 Code of Federal Regulations (CFR) section 200.320.

DISCUSSION:

Procedures outlined in government-wide regulations at 2 CFR section 200.320 provide that state agencies and program operators are responsible for determining and documenting an appropriate micro-purchase threshold based on internal controls, an evaluation of risk, and its documented procurement procedures. The regulations also provide that the micro-purchase threshold used must be authorized or not prohibited under state, local, or tribal laws or regulations. State agencies and program operators may establish a micro-purchase threshold that is higher than the federal threshold established in the Federal Acquisition Regulations (FAR).

Pursuant to 48 CFR section 2.101, an acquisition of supplies or services below the threshold of \$15,000 is, for the purpose of federal law, a “micro-purchase” which does not require formal procurement methods such as competitive bidding. The District is currently bound by the federal micro-purchase threshold of \$15,000 for applicable transactions funded by federal funds. Pursuant to 2 CFR section 200.320, non-federal entities, including local public school districts, may annually self-certify a micro-purchase threshold of up to \$50,000 if (1) the non-federal entity qualifies as a low-risk auditee, (2) the non-federal entity has an annual internal institutional risk assessment to identify, mitigate, and manage financial risks, or (3) a higher threshold would be consistent with state law.

The District is requesting approval to self-certify increasing the federal micro-purchase threshold to \$50,000.

This item will appear on the March 4, 2026, consent agenda.

FISCAL IMPACT:

Increasing the micro-purchase threshold will result in purchase and project lead time reduction and cost savings.

**SELF-CERTIFYING INCREASED FEDERAL
MICRO-PURCHASE THRESHOLD**

WHEREAS, pursuant to 48 Code of Federal Regulations (CFR) section 2.101, an acquisition of supplies or services below the threshold of \$15,000 is, for the purpose of federal law, a “micro-purchase” which does not require formal procurement methods such as competitive bidding; and

WHEREAS, the Clovis Unified School District is currently bound by the federal micro-purchase threshold of \$15,000 for applicable transactions funded by federal funds; and

WHEREAS, pursuant to 2 CFR section 200.320, non-federal entities, including local public school districts, may annually self-certify a micro-purchase threshold of up to \$50,000 if (1) the non-federal entity qualifies as a low-risk auditee, (2) the non-federal entity has an annual internal institutional risk assessment to identify, mitigate, and manage financial risks, or (3) a higher threshold would be consistent with state law; and

WHEREAS, the District may permissibly self-certify a higher micro-purchase threshold under the third potential justification set forth above because it would be consistent with state law, since California has higher thresholds. Specifically, California Uniform Public Construction Cost Accounting Act (UPCCAA) allows for purchase orders to be issued for public projects as set forth in Public Contract Code section 22000, a copy of which is attached hereto as **Exhibit A**; and

WHEREAS, for contracts and purchases for other goods and services, California generally requires competitive bidding for contracts and purchases over \$119,100. This threshold is in accordance with Public Contract Code section 20111(a), as has been adjusted pursuant to statute by the California Department of Education, as documented in the letter attached hereto as **Exhibit B**; and

WHEREAS, in accordance with the above, the District is justified in self-certifying a micro-purchase threshold of \$50,000 for contracts, purchase and for public projects.

THEREFORE, BE IT RESOLVED by the Board as follows:

1. The above recitals are true and correct.
2. The Board hereby self-certifies a limit of \$50,000 for federally funded micro-purchases provided that such purchases comply with all applicable laws.
3. The Board hereby instructs District staff to retain this resolution, as well as its exhibits, for a period of three years, in accordance with 2 CFR § 200.334.

EXHIBIT A
California Public Contract Code section 22000

ARTICLE 1. Legislative Intent and Definitions [22000 - 22003]

22000.

This chapter shall be known and may be cited as the “Uniform Public Construction Cost Accounting Act.”

22001.

The Legislature finds and declares that there is a statewide need to promote uniformity of the cost accounting standards and bidding procedures on construction work performed or contracted by public entities in the state. This chapter provides for the development of cost accounting standards and an alternative method for the bidding of public works projects by public entities.

22001.5.

On or before January 1, 2009, the Controller shall send a notice to all public agencies describing the provisions of this chapter and the benefits of using its provisions. This notice shall also be included in any notification issued by the Controller pursuant to Section 22020.

22002.

(a) “Public agency,” for purposes of this chapter, means a city, county, city and county, including chartered cities and chartered counties, any special district, and any other agency of the state for the local performance of governmental or proprietary functions within limited boundaries.

“Public agency” also includes a nonprofit transit corporation wholly owned by a public agency and formed to carry out the purposes of the public agency.

(b) “Representatives of the construction industry” for purposes of this chapter, means a general contractor, subcontractor, or labor representative with experience in the field of public works construction.

(c) “Public project” means any of the following:

(1) Construction, reconstruction, erection, alteration, renovation, improvement, demolition, and repair work involving any publicly owned, leased, or operated facility.

(2) Painting or repainting of any publicly owned, leased, or operated facility.

(3) In the case of a publicly owned utility system, “public project” shall include only the construction, erection, improvement, or repair of dams, reservoirs, powerplants, and electrical transmission lines of 230,000 volts and higher.

(d) “Public project” does not include maintenance work. For purposes of this section,

“maintenance work” includes all of the following:

(1) Routine, recurring, and usual work for the preservation or protection of any publicly owned or publicly operated facility for its intended purposes.

(2) Minor repainting.

(3) Resurfacing of streets and highways at less than one inch.

(4) Landscape maintenance, including mowing, watering, trimming, pruning, planting, replacement of plants, and servicing of irrigation and sprinkler systems.

(5) Work performed to keep, operate, and maintain publicly owned water, power, or waste disposal systems, including, but not limited to, dams, reservoirs, powerplants, and electrical transmission lines of 230,000 volts and higher.

(e) For purposes of this chapter, “facility” means any plant, building, structure, ground facility, utility system, subject to the limitation found in paragraph (3) of subdivision (c), real property, streets and highways, or other public work improvement.

22003.

A public agency which has, by resolution, elected to become subject to the uniform construction cost accounting procedures set forth in Article 2 (commencing with Section 22010), may utilize the bidding procedures set forth in Article 3 (commencing with Section 22030) when contracting for "maintenance work," as defined in Section 22002, or when contracting for any other work which does not fall within the definition of "public project," as defined in Section 22002.

Dear County and District Superintendents, County and District Chief Business Officials, and Charter School Administrators:

Annual Adjustment to Bid Threshold for Contracts Awarded by School Districts

Public Contract Code (PCC) Section 20111(a) requires school district governing boards to competitively bid and award any contracts involving an expenditure of more than \$50,000, adjusted for inflation, to the lowest responsible bidder. Contracts subject to competitive bidding include:

1. Purchase of equipment, materials, or supplies to be furnished, sold, or leased to the school district.
2. Services that are not construction services.
3. Repairs, including maintenance as defined in *PCC* Section 20115, that are not public projects as defined in *PCC* Section 22002(c).

The State Superintendent of Public Instruction (State Superintendent) is required to annually adjust the \$50,000 amount specified in *PCC* Section 20111(a) to reflect the percentage change in the annual average value of the Implicit Price Deflator for State and Local Government Purchases of Goods and Services for the United States, as published by the United States Department of Commerce, Bureau of Economic Analyst (BEA) for the 12-month period ending in the prior fiscal year. The inflation adjustment is rounded to the nearest one hundred dollars (\$100).

Pursuant to the above calculation, and effective January 1, 2026, the State Superintendent has determined that the inflation adjusted bid threshold will increase from \$114,800 to \$119,100. Shown below are the inflation adjusted bid thresholds for the current and two prior years.

Calendar Year	Bid Threshold	Percentage Change in Implicit Price Deflator
2024	\$114,500	4.79%
2025	\$114,800	0.259%
2026	\$119,100	3.772%

Also note that public projects as defined in *PCC* Section 22002(c), such as construction or reconstruction of publicly owned facilities, have a lower bid threshold of \$15,000 that is not adjusted for inflation. For more information on bidding requirements for all projects, refer to *PCC* sections 20110 to 20118.4.
